Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## ----- page 221 -----THE PETITION OF CAPT. HANCE BOND

To the Honorable the General Assembly of the State of North Carolina now sitting. The Petition of Hance Bond, Captain of Marines on board the Ship *Caswell*, <sup>1</sup> Humbly Sheweth,

That your Petitioner hath served this State as Captain of Marines on board the said ship *Caswell* eleven months under a Commission from his Excellency, Governor Caswell; that the said ship is now laid up, and the materials, Stores and men are removed on board the ship *Washington*. <sup>2</sup>That your Petitioner, with his Officers and Marines, have not received their pay; he therefore prays your Honors to afford him such relief as you in your great wisdom shall think proper, and your Petitioner, as in duty bound, shall ever pray.

HANCE BOND

*Caswell.* Coggins:102, ND6:1417, ND7:121, ND8:175, ND9:37, ND10:802, ND11:191, row galley of the VA Navy, 1776-79, Capt. Willis Wilson, built at South Quay on the Blackwater for the defense of Ocracoke Inlet. Coggins: 106, this galley was to be purchased by the NC Navy, but she sank on station in June 1779.

Caswell. ND4:570, ND6:1042, armed schooner, arrived at Newbern from St Eustatius, 28 March 1776.

*Caswell.* ND6:1042, NC sloop, active fall 1776. ND9:108, 180, 195, NC privateer sloop, Capt Lemuel Palmer, captured U/I brig in 1777.
