Pension application of William Stone R10220 Sarah Stone f28VA

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Indiana Vermilion County: SS: On this 17th day of August 1843 before the Subscriber one of the Associate Judges of the Circuit Court in and for the County and State aforesaid personally appeared Sarah Stone a resident of said County aged 84 – years who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 4, 1836, that she is the widow of William Stone who was a private in the Army of the Revolution for three periods of three months each in the Virginia Militia – that she remembers that the first time that her husband was drafted was at a time when she had one child that she does not know under what officers he served in the first trip as aforesaid – but he was during all these three tours of service she and her said husband resided in the County of Halifax in Virginia from the militia of which County he was drafted as aforesaid that his first trip she thinks was done in the year 1777 or 8, that the second trip of three months was performed under a Captain Coleman of Halifax County Virginia and was she thinks in the year 1779 or 1780 but she is not positive as to the year, that the third trip of three months was in the year 1781 she remembers that the third tour he entered the service in the month of May after the Battle of Guilford Court House [March 15, 1781]¹ – That when he went on this third trip she had her third child whose name was John Stone and that said John her son was killed by a horse at about the age of twenty four or five years in the said County of Halifax, that she knows he was a drummer in the second tour but whether he was a drummer or soldier in the two other trips she does not know – That she is the mother of sixteen children – That she has no Record of the ages of her children unless it exists in a Bible left with her son David Stone in Wilkes County North Carolina that she was married in Person County North Carolina and immediately removed into the adjoining County of Halifax Virginia – That she thinks Abram Gregory, ² John Gray and Thomas Branam and William Gill were with him. She remembers hearing her husband speak of said Gill having his horse shot under him in one of these tours. She further declares that she was married to the said William Stone on the 12th day of October 1775 or 1776. That her husband the aforesaid William Stone died on the 27th day of December 1824 and that she has remained a widow ever since that period as will more fully appear by reference to the proof hereunto annexed.

Vermilion County SS Before me Ashley Harris one of the associate Judges of the Circuit Court in and for the said County personally appeared Job Hatley a resident of said County who being first duly sworn upon his oath says that William Stone the husband of the above named Sarah Stone died on the 27^{th} day of December 1824 and that the said Sarah Stone who is the mother of the Deponent's wife³ has not intermarried since the Death of the said William Stone but she is his Widow.
