I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Ohio Shelby County SS

On this 8th day of November A.D. 1850 personally appeared before me a Justice of the Peace within and for the County & State aforesaid Rodham Talbott, aged 87 years a resident of Shelby County in the State of Ohio who being duly sworn according to law declares that he is the identical Rodham Talbott who was a private in the Company commanded by Captain William Mason and Colonel Ryan of militia men in the Revolutionary war with Great Britain declared by the United States.

That he volunteered in Fairfax County Virginia on or about the 20th of May AD 1781 or 1782 (he does not recollect which year). That he actually served three months and was honorably discharged at Colechester [Colchester] then in Fairfax County Virginia on or about the last of August A.D. 1781 or 1782 as well up here by the muster rolls of said company. Deponent further states that neither he nor anyone of the Company received a written discharge but that the entire company was honorably discharged by Colonel Ryan's verbal command.

He makes this declaration for the purpose of [indecipherable word, perhaps intended to be "claiming" his pension to which he is now an long has been entitled to under the old pension act of Congress granting pensions to Revolutionary Soldiers & officers &c
