[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

[f p. 2: Certificate from the clerk of the Brunswick County Virginia court stating that the records of said court show that Betsey Thompson orphan of William Thompson was bound as an apprentice to John Nicholson October 24, 1789. The certificate is not dated.]

[f p. 4: power of attorney given by William Brown in which he states that he is one of the heirs of William Thompson deceased a soldier of the revolution. The power of attorney is dated June 30, 18?2 [third digit unclear] in Greene County of Ohio. William Brown signed the document with his mark. His relationship, if any to the veteran is not stated.]

Be it known that before me B. Nesbitt a Justice of the Peace in and for the County and state aforesaid duly authorized to administer oaths personally appeared Margaret Cain, Betsey Moton and William Brown and made oath in due form of law that they are the children and heirs of Betsey Roberd deceased who was the daughter and heir of William Thompson who was a Soldier in the War the Revolution and who served four years and four months in said war in the American Continental Line in the State of Virginia and died during said war while in the service of the United States. They do not know what Company or Regiment he served in but herewith send two affidavits made by his comrades in the service which they hope will throw some light on the matter. They make this declaration for the purpose of obtaining from the United States the amount due them as heirs of said William Thompson for the four years and four months service rendered by said William Thompson in the war aforesaid

[f p. 9: Finding by the Clerk of court of Greene County of Ohio that satisfactory evidence has been presented to him that William Thompson was a soldier of the American Revolution; that he is dead; that he was not survived by any widow; that he only left one orphan whose name was Betsey Thompson; that Betsey Thompson married Abraham Roberd and that she is also dead and that she left four children surviving her namely: Polly Matthews, Betsey Moton, Margaret Cain and Lucy Brown who is dead and left one son who is now living William Brown. The finding is dated <u>March 1852.</u>]

[f p. 11: Certificate dated April 19, 1799 in Brunswick County Virginia signed by Ira Ellis stating that he joined together in the state of matrimony Abraham Roberd and Betsey Thompson.]

Brunswick County to wit:

This day William Stainback personally appeared before me a Justice of the Peace for the County aforesaid and made oath that he was acquainted with Will Thompson and that he was a regular soldier in the Continental Army & that he was killed or died during the Revolution this the 26th day of November 1827.
