[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, County of Warren

On this 29th day of October 1842, personally appeared before me John P. Shearin, one of the acting Magistrates & a member of the Court of Pleas & Order Sessions (it being a Court of record) for said County in said State, Susan Thompson, a Resident of said County & State aged 86 years, who, being first duly sworn according to law, doth, on her Oath, make the following declaration, in order to obtain the benefit of the provision made by the act of Congress passed July 4, 1836: That she is the widow of Drewry Thompson, who was a private in the North Carolina Militia, & served six months as such in the year 1781,

She further declared that she was married to the said Drewry Thompson, on the 1st day of January in the year 1776, that her husband, the said Drewry Thompson, died on the 15th day of March 1828; and that she has remained a widow ever since that period, as will more fully appear by reference to the proof hereunto annexed.

I Frederick Shearin¹ a Revolutionary Pensioner of the County of Warren, State of North Carolina, aged 81 years, certify on oath, that Drewry Thompson was a Militia Soldier in the N. C. service in the Revolution and did serve as such, for three months, from the 10th of February 1781 to the 10th May 1781. The said tour he Thompson & myself served together the above Tour of three months, & were together at the Battle of Guilford C. H. [March 15, 1781] -- North Carolina which occurred about the middle of March 1781.

I also certify that the said Drewry Thompson married Susan Lankford, some four or five years before the above service, in 1781. I well recollect of being present when they were married and they always since, until the month death of said Drewry Thompson, lived together as husband & wife, and the said Drewry Thompson died some Dozen years past, & the said Susan Thompson his widow is now a widow & has never married since the death of her said husband Drewry Thompson.

I Francis Riggan,² aged 79 years, make oath that Drury Tompson was a Revolutionary Soldier & did serve a Tour in the North Carolina commencing in February 1781 -- & also the said Drury Tompson did serve one other tour of three months in the Militia under Captain Turner [Nathan Turner] commencing in July 1781 – which Tours I know the said Drury Tompson did serve because he was & did serve with me, as a Soldier & I so say on oath that the said Tompson served six months in the N. C. militia.

Also saith on oath that for several years before 1781 – Drewry Tompson & wife Susan were living together as man and wife & did so continue to live until Drury Tompson died which occurred upwards of 10 years past. Susan Tompson his widow is now a widow & has never married since he died.
