Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

North Carolina Cherokee County: SS

On this 21st day of February A.D. 1853, personally appeared before me a justice of the peace within & for the County of Cherokee & State of North Carolina Jemima Crump, wife of John Crump, the youngest & only child of (Martin Trap deceased) known to be alive aged fifty-five years together with her Husband who being duly sworn declares that she is the Daughter of said Martin Trap who was a private Soldier enlisted during the Revolutionary War with Great Britain by Captain Davison in the 6th Regiment of Virginia commanded by Colonel Philips said Trap was in the Battles of Brandywine [September 11, 1777], Guilford [March 15, 1781] & Eutaw Springs [September 8, 1781] was discharged at James Island near Charleston South Carolina, that the said Martin Trap died about the 6th or 7th of November 1826. That the said Jemima Crop was married to John Crump about November 1812 by David Ripploe Esquire and that she and said John Crump are still alive & living in Cherokee County North Carolina.

The said Jemima Crump & John Crump makes this declaration for the purpose of obtaining the Pension money & Bounty Land that she might be entitled to as heir at law to her father Martin Trap under any & all of the late Acts of Congress in those cases made & provided; never having received either Pension Money or Bounty Land now made previous application.
