[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

On this 5th day of April A.D. 1844 personally appeared before me Doctor C. Parish one of the Acting Justices of the peace for said County Elizabeth Umsted a resident of the County & State aforesaid aged eighty-six years who being duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4th A.D. 1836 that she is the widow of David Umsted who was a private soldier in the revolutionary war and that he entered service in the County of Orange North Carolina (but that she is not able to give any further particulars as specified in rule number four) but she declares that he served (agreeable to the best of her recollection) in a nine months tour after their marriage and further saith that she was married to the said David Umsted only 8th day of February A.D. 1779 but that she knows of no person living by whom she can positively prove their marriage. She further declares that the said David Umsted died in the County State aforesaid on the 8th day of September A.D. 1804 and that she has remained a widow ever since that period which will more fully appear from the proof hereunto annexed. This day personally appeared before me the undersigned one of the acting Justices of the peace for said County David Green of the County of Orange and made oath in due form of Law that David Umsted late of the said County of Orange did render service for a considerable time in the revolutionary war but how long he cannot say and that the said David Umsted and Elizabeth Green he believes were lawfully married and that he knows they lived together as man and wife for many years and had several children he further states that he was frequently at the house of the said David Umsted during his absence in said war & frequently heard Elizabeth the wife of the said David Umsted speak of the circumstance of her husband during his absence and he further declares that Elizabeth Umsted is the widow of the said David Umsted who served in said War and further declares that the said David Umsted lived and died in the County of Orange. Sworn to & subscribed the 24th of April A.D1844.

On the 17th of February 1845 personally appeared before me the Subscriber an acting Justice of the Peace in & for said County Elizabeth Umsted a resident of Orange County aged 86 years who being duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 4th 1836. That she is the widow of David Umsted who was a Soldier in the revolutionary War and to the best of her recollection was a private in the Militia but to what Regiment he was attached she

cannot recollect, but thinks a man by the name of Lytle was the Colonel and that the Captain's name was Carrington [James Carrington]. She further declares that she cannot recollect the particular period when her husband entered the Service but she further declares that her husband was drafted or taken from her after her Marriage to him and served a term of nine months and that he marched from Hillsboro N. C. to Deep River and there remained for a considerable time and from thence he marched to Charleston (SC) and from thence to Hillsboro N. C. and that he was at other places which he cannot recollect. She further declares that she has no documentary evidence in support of her Claim. She further declares that according to a family record kept by her said husband that she was married to the said David Umsted in the Winter of 1779 and that the said family Record will show when her husband Died and that she has remained a widow since that period, as will more fully appear from reference to the proof hereunto annexed. She further declares in consequence of old age and bodily infirmity that she cannot appear in open Court to make this declaration.

That he was well acquainted with David Umsted a soldier of the Revolutionary War that he served with the said Umsted for the period of nine months & that they served under Captain Carrington and that the said David Umsted lived & died in Orange County & that Elizabeth Umsted now applying for a pension is the widow of said David Umsted. On this the 22nd day of February 1845 personally appeared before the Subscriber a Justice of the peace in & for said County George Carrington aged 94 years a Soldier of the Revolutionary war and a Pensioner and made oath in due form of law to the following affidavit,

That he was well acquainted with David Umsted, a Soldier of the Revolutionary war that he served with the said Umsted for the period of nine months, and that they served under Captain Carrington and that they marched from Hillsborough to Deep River and there remained for the space of five or six months and that they marched from Deep River to Charleston South Carolina & from thence to Stonono [sic, Stono] and from thence back to Hillsborough from whence they first started in the said David Umsted lived & died in the County of Orange and that Elizabeth Umsted now applying for a pension is the widow of the said David Umsted.
