Pension application of John Wagstaff R10998 Transcribed by Will Graves fn10VA 7/21/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Virginia Mecklenburg County:

On this 19th day of November 1832 personally appeared in open Court before Wm Bushell, Erasmus Kennon, Abram Kern & Thomas Workman the court of Mecklenburg now sitting John Wagstaff a resident of Mecklenburg County and State of Virginia, aged eighty years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832. That he entered the service of the United States under the following named officers, and served as herein stated.

In the month of January in the year 1781 he resided in Mecklenburg County and State of Virginia, he was there drafted, detailed to march in the lower part of Virginia, he rendezvoused at Speed's Church in said County, and from thence, (under the command of Colonel Robert Munford, Colonel David Stokes and Captain James Hall, he marched to Portsmouth in Virginia, and there joined Colonel Downman [may be Lt. Col. Raleigh or Rawleigh Downman] and Major Duval, from thence he marched to a place called Jericho, from thence he marched back to Portsmouth, and remained in the vicinity of Portsmouth, until he received information that his family was sick, he then hired a substitute, who served the residue of his tower [tour] of three months, and he the said John Wagstaff returned home.

In the month of September in the same year, he was again drafted and detailed to march to the lower part of Virginia, he marched under the command of Colonel Lewis Burwell, Major Henry Walker, Captain William Jeffries & Captain Elijah Graves he marched to Hog Island on James River, and there crossed said River, and from thence marched to Williamsburg in Virginia, and from thence he marched to Gloucester County in Virginia, and there joined General Weden [George Weedon or Weeden], and was there stationed when the British Army surrendered at Yorktown, he was there discharged and returned home in November in the same year. He hereby relinquishes every claim whatever to a pension or annuity but the present, and declares that his name is not on the pension roll of the agency of any state, he has no documentary evidence of his having the service, or of his having been discharged from the service & that he served 6 months in all.

Sworn to and subscribed the day and year aforesaid

Mecklenburg County: SS

This day Obadiah Coleman came before me Joseph R Clausel a justice of the peace for the said County and made oath that he has known John Wagstaff for many years, that he thinks he is 80

years of age, and that he served a tower of duty in the militia with the said John Wagstaff in the Revolutionary war, and was with him, when the British Army was captured at Yorktown, and that he knows that the said John Wagstaff, had before that he served a tour of duty in the militia, and that the said John Wagstaff is a respectable man, and deserving of credit, and that the said Obadiah Coleman¹ is blind and from old age and infirmities cannot attend court. Given under my hand the 15th day of November 1832.
