[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[p 3: On November 17, 1849 in the city of Richmond, Virginia, Robert Morrissett, administrator of the will of Captain Edward Woneycutt, deceased, filed a power of attorney appointing James Murdaugh of Portsmouth Virginia his attorney to pursue the half pay due the decedent for his service as a Captain in the Virginia State Navy under the act of Congress of July 5th, 1832. Morrissett states in the power of attorney that Murdaugh is to receive one third of the amount recovered pursuant to the power of attorney.

Pension Office July 30, 1845

I hereby certify that I have examined the claim of the administrator of Edward Woneycott [sic], and I find that under the act of 5th of July 1832 entitled "an act to provide for liquidating and paying certain claims of the State of Virginia," half pay was allowed as a Lieutenant of the Virginia State Navy at the rate of \$182.50 per annum from the 22nd of April 1783 to June 1, 1811; whereas the claim should have been allowed for the service of said Woneycott as a Captain in the Virginia State Navy at the rate of \$250.93 per annum for the above mentioned period. The difference between the half pay as a Lieutenant and that of a Captain is now demanded, and my opinion is that the amount should be paid. I therefore certify that after deducting what has been already paid the administrator should be allowed a half pay at the rate of \$250.93 per annum from April 22nd 1783 to June 1, 1811, and it is requested by the administrator Robert Morrisset of Portsmouth, Virginia, that the money may be sent in a draft directed to the care of the cashier of the Exchange Bank of Virginia.

Edward Woneycutt was appointed Lieutenant on the 27th of March under Captain Taylor [Richard Taylor] of the Navy. In December 1776 Woneycutt was Captain of the *Hornet*⁴ was afterwards Captain of the *Greyhound*⁵ and continued as such (as appears by the accompanying extracts) as late as the 19th of December 1778, but how much later does not appear. By reference to the accounts of the Ship Cornerant [*Cormorant*]⁶ in the Navy Journal lately found by Mr. Smith, and bound, under the dates of the 16th of April 1782 & 4th of May 1782 volume 2nd, Captain Maxwell [James Maxwell]⁷ charged the state with payment to Woneycutt as commander of one of the State Vessels. J. W. Murdaugh on behalf of the heirs of Woneycutt asks that the proportion of land due to a Captain in the Navy may be allowed.

WONICUTT [WONYCUTT, WOYNCUTT, WORRYCOTT], EDWARD VA Captain, Virginia Navy

Edward Wonicutt [Wonycutt, Woyncutt, Worrycott] was appointed as First Mate in the Virginia Navy under Captain Richard Taylor. He was commissioned on 5 December 1776 to command the Virginia Navy Brig *Greyhound*, being built at Mingles Ferry. [NOAR, 344] He is not listed in Stewart, *Virginia's Navy of the Revolution*. He was commissioned as a Lieutenant in the Virginia Navy in 1777. He commanded the *Greyhound*. [NOAR, 342]

Addendum to Edward Woneycutt R110

Transcribed and annotated by C. Leon Harris. 1 July 2023.

[From bounty-land records in the Library of Virginia.]

Edward Woneycutt was appointed Lieutenant on the 27th of March under Capt. Taylor [Richard Taylor S25873] of the Navy. In December 1776 Woneycutt was Captain of the Hornet – was afterwards Captain of the Greyhound & continued as such (as appears by the accompanying extracts) as late as the 19th of Dec'r 1778. But how much later does not appear. By reference to the accounts of the ship Cormorant in the Navy Journal lately found by Mr Smith & bound, under dates of the 16th of April 1782 & 4th of May 1782 [undeciphered] Capt Maxwell [James Maxwell R73] charged the state with payments to Woneycutt as Commander of one of the State vessels. J. Murdaugh on behalf of the heirs of Woneycutt asks that the proportion of land due to a Captain in the Navy may be allowed Richmond January 17th 1833

Capt. Ed. Woneycutt/ Land Bounty for 6 years service in the State Navy/ 53331/3 Acres

This claim is suspended by on order to the Register to ascertain whether or not the Greyhound was a Vessel [undeciphered word] in the Navy or Board of Trade – if to the former, land bounty is due – if to the latter, no land is allowed. J. F. [Gov. John Floyd]

Richmond Augt 10 1836

To his Excellency Gov'r [Wyndham] Robertson

Sir On the 15th of April 1833 the Executive allowed Land bounty to the heirs of Edward Woneycutt as a Lieutenant in the State Navy. The application was made to be allowed the bounty of a Captain in the Navy, and I was at a loss to know why he was allowed only as a Lieutenant. I called on Gov'r. Floyd & he remarked that the Bounty to a navy Lieutenant, & to a Captain of a vessel of the size commanded by Capt. Woneycutt was the same, that it was unnecessary to alter the advice. I acquiesced & permitted the matter to rest – but since then (as I am informed by the Register) all Captains in the navy are allowed the same quantity of land without regard to the size of the vessel, & it is of some importance now that the advice should be corrected by which a warrant for 1333½ acres will be due the heirs. I presented the claim to the U. S. Treasury Dept. for half Pay, & although the Dept was satisfied that Woneycutt was a Captain, yet as he had been allowed only a Lieutenant's bounty it was there decided to allow him only a Lieutenant's Half Pay. I have to request your Excellency to reexamine the case & that you will direct the additional allowance of Land to be made. I have the Honour to be yr Excellency's Ob Ser't.

To His Excellency The Governour of Virginia

J W Murdaugh on behalf of the heirs of Captain Edward Woneycutt respectfully represents that Land bounty was allowed some years ago to Woneycut as a Lieutenant in the State Navy. The evidence herewith inclosed proves that he was duly commissioned a Captain & was in the command of the armed State Brig Greyhound. The heirs now petitioned to be allowed the difference of land which is usually allowed to Lieutenants & Captains which will be 1333 acres. Woneycutt heirs receive From the Secretary of the Treasury Half Pay for service to the end of the War

Richmond Jany 24th 1838

To the Governor

Sir I find upon examination that Dr. Pell [Joseph Simon Pell R84] has been allowed all the land that he is entitled to. I therefore wish no action by the Executive on that claim Feby 15th 1838 very respectfully/ J W Murdaugh

There is not among the papers filed in this case satisfactory evidence that Capt Wonicutt served in that capacity three years. Claim as Captain cannot be allowed DC [Gov. David Campbell] 1838 Mar 27 Rejected

Claim of Heirs of Edw Wonicutt for bounty land as Captain in State Navy 1838 March 31. This case has been again re-considered & examined. And the entries in the accounts of

The Greyhound dated 16 Ap'l 1779 have been found & examined. If Wonicutt was a Captain, as it would appear he was, then his heirs have not made out a service for three years. The entries in the account of the 16th of Ap'l 1779 do not prove any thing. Claim rejected DC

in my own right as husband of one of the daughters of said George R Enslow dec & Ann Morissetts (which said Mary & Ann are daughters of said George R. Enslow dec.) Have constituted and appointed & by these presents do constitute & appoint Isaac Enslow one of the sons of said George R. Enslow our true and lawful Attorney for us and in our own rights & names & in the name of the said Robert Morrissett in his said several representative characters, to receive of the Secretary of the Treasury of the United States all certificates of Military Scrip issued or to be issued to Capt. Edward Wonicutts heirs for his services in the Virginia State Navy and to assign & transfer the same as fully & effectually as we could do ourselves in our own proper persons – and also to receive of the said secretary all sums of money that may be due us for Half Pay as the heirs and representatives of the said Capt. Ed. Woneycutt and we do furthermore authorise our said Attorney & vest him with full power to grant receipts in our names and to substitute under him an Attorney or Attorneys for the purpose of receiving the said Scrip & monies & for the assignment & transfer of said Scrip – Hereby confirming & ratifying whatsoever our said Attorney shall do or cause to be done by substitution in and about the premises

NOTE:

The Virginia Half-Pay file includes a copy of the last will and testament of Edward Woneycutt dated 20 January 1794 and proved on 15 July 1811 naming his sister, Mary Shays as heir and Nicholas Woneycott as executor. Other documents name George Enslow as the son and only heir of Mary Shays "who was Mary Enslow before her second marriage with Shays." In addition, there is a copy of the last will and testament of George R. Enslow dated 24 June 1832 and proved on 15 July 1833 nominating his son-in-law, Robert Morrisset as executor and directing that the proceeds from the sale of land warrants and scripts for the services of his uncle, Edward Wonycott, be divided among his two daughters and two sons if still living.
