## Pension application of Aaron Wallace R11062 Transcribed by Will Graves

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." ## State of Ohio Hamilton County: SS

On this 12th day of March A.D. 1833 personally appeared before the Court of Common Pleas of Hamilton County Aaron Wallace a resident in the said County of Hamilton, in the State of Ohio aforesaid aged about seventy-four years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th, 1832, that he enlisted in the arms of the United States, in the month of June, in the year 1782, according to the best of his recollection. That he does not know the number of the Regiment or of the line in which he enlisted, in Wayne County State of North Carolina in a company of which Benjamin Coleman was Captain, and in a Battalion of which Redding Blount was Major. That his first place of rendezvous was Kingston [sic, Kinston], NC from whence he was marched to Wilmington NC under Cape Fear River. From thence to Georgetown on the River Pedee in South Carolina, and from thence to Ashley Hill, where General Green [sic, Nathanael Greene] was in command. There he was transferred to a company commanded by Captain William Lytle, in a Regiment commanded by Colonel Archibald Lytle, the number of which he does not know. From Ashley Hill he was marched to James Island and remained there until the death of the peace when he was discharged. The written discharge he received, was destroyed by watching in his pocket on the way home, while he was sick of the measles. He hereby relinquishes any claim whatever to a pension or annuity, except the present, and he declares that his name is not on the pension roll of any agency in any State. Sworn to and subscribed the day and year aforesaid in open Court. Sworn to and subscribed before me in open Court marched 12th, 1833 S/ Danl. Gano, Clk S/ Aaron Walls [sic]
