Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Mississippi County of Leake} SS: On this day personally appeared before the Worshipful Court for said County now in Session Mrs. Bethia Watson resident of said County who in due and solemn form of law doth on her oath declare that she is the widow of John Watson who was a revolutionary soldier from the State of South Carolina Chester district that she was married to the said John Watson in the State of Virginia in the year 83 that she is about Eighty five years of age that the said John Watson served under Wade Hampton and was honorably discharged at the close of the Revolutionary war in 1780 to 1783, that her said husband died in the State of South Carolina in the year 1810 [could be 1816] and having become entitled to pension for said service and not having applied for the same. And under the act of 1832 if living would have been entitled from 4th of March 1831 and if married prior to 1794 his widow would be entitled from the 4th of March 1836 she the said Bethia Watson widow of John Watson now prays that her name be subscribed on the Roll of widows of Revolutionary soldiers drawing pensions, and that pension in right of said husband be granted to her from the 4th of March 1836 during her natural life subscribed and sworn in open court December 26, 1853

State of Mississippi Leake County: Personally appeared before me this day M. U. Joiner acting Justice of the Peace in and for said County, Mrs. Sarah Watson deposes and saith, she has every reason to believe that John Watson husband of Bethia Watson now a widow was a soldier in the Revolution in active service and that said John Watson went from Chester District South Carolina and that said Bethia Watson is the widow of said John Watson and that said John Watson and Bethia his wife sustained a loss by fire which consumed all their effects including bedding, papers &c and that his discharge was consumed at that time.
