## Pension application of Samuel F. Williams R11618 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Kentucky, Henderson County

On this 22<sup>nd</sup> day of 7<sup>th</sup> Month, 1833, personally appeared in Open Court before the Honble [sic, Honorable], the County Court of Henderson, Kentucky aforesaid now sitting Saml. F. Williams, a resident of said County and State aged 74 – years, who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress of June 7<sup>th</sup>, 1832 and the Resolution of Congress last Session supplementary thereto (has insert[ed] all his Services Even to a day). The he Enlisted [in] the service of the United States under the following named Officers and served as herein stated that in the year 1780 he attached himself to a Dragoon Regiment of the North Carolina Militia as a volunteer under Capt. Samuel Snead, the regiment commanded by Col. Wm. Richardson Davy [William Richardson Davie] & Col. Philip Taylor, & served for two months but were allowed for 3 months, as we found our own horses, marched from Granville Courthouse thro' Hillsborough & Salisbury to near Charlotte Court House. Returned home - was drafted again as a militia man, & sent on a substitute for 3 months, the name not remembered, was drafted again - & substituted Wm Rochester [William Rochester] in my stead for 12 months or near - recollects Col. Daniel Morgan & Col. Washington [William Washington] of the Virginia Continental line.

He has no documentary evidence except a Certificate which was lost and knows of no person where testimony he can procure, who can testify to his Services except Jno. Moss¹ of this county, who here testifies to my services -- & served with him.

He hereby relinquishes every desire whatever to a pension, except the present and declares that his name is not on the pension roll of the agency of any state.

Williams who has subscribed, sworn to the above declaration, that we believe him to be 74 years old, that he is believed & respected in the neighbourhood where he resides to have been a soldier of the Revolution and we concur in that opinion.

Interrogatories put to Samul. F. Williams an applicant for pension &c by the Honble, the County Court of Henderson Co., Ky

- 1. Where and in what year were you born. In Granville NC in 1759.
- 2. Have you any record of your age? Ans: recorded, but lost & if so where is it?
- 3. Where were you living when called into service; where have you lived since the revolutionary War & where do you now live? In Granville Co. NC till 1805 & afterward in Henderson Co. KY
- 4. How were you called into service,-- were you drafted; did you volunteer or were a substitute, & if a substitute for whom? Ans: I volunteered for 3 months & found the 2 substitutes for 15 more.
- 5. State the names of some the regular officers who were with the troops where you served, such continental and militia regiments as you can recollect and the general circumstances of your service Col. Danl. Morgan & Col. Washington are the only officers recollected.
- 6. Did you ever receive a discharge from the service & if so, by whom was it given and what has become of it? Ans. I recd. a certificate and it is destroyed.
- 7. State the names of persons to whom you are known in your neighbourhood and who can testify to your character for truth and their belief of your services, as a soldier of the Revolution. Saml. Denton, Joshua Moss, & Wm Jones & Edwd H. Vaughn.

[Note: There is a power of attorney dated August 4<sup>th</sup>, 1853 filed in Henderson County Kentucky and executed by Alfred Williams, Susan Williams & Jane D Harding residents of Henderson County who state that they are the a heirs of Samuel F Williams an applicant for a pension for his services in the revolutionary war.

[Note: Based on his testimony that he served only 2 months of active duty during the revolution, this veteran would not have qualified for a pension under the 1832 (or any other) Act. Six months of actual service was required to qualify for a pension. Services by substitutes were not includable to meet the 6 months requirement.]
