Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Louisiana Parish of Natchitoches: March the 14th A.D. 1835

Personally before me the undersigned authority came and appeared Mr. Edmund Quirk who being duly sworn according to law made oath that he is well acquainted with Jesse Yocum of said parish and state aforesaid and that he knew him in Kentucky where they both lived in the year 1780 and that he knew of said Yocum's voluntarily entering in the Militia Service of said State in the company of Captain Hugh McGary in Colonel John Bowman's Regiment and that he knew said Yocum to go against the Shawanie Indians [Shawnee Indians] in what was called General Clarke's Expedition witness thinks in the year 1780 or 81. And that he knew of said Yocum's being taken prisoner in the Blue Lick action [August 19, 1782, Battle of Blue Licks or Bluelicks] witness being in the same Action and that he knew of said Yocum's being absent more than one year and he understood by common report he was carried to Detroit and from thence to Montréal in Canada, and that he attempted to desert was retaken and from that time was kept in irons until he was Discharged at the End of the war and witness knows that he returned home to Kentucky in the month of August 1783.

[There is a 2-page letter dated Jany. 13, 1833 from James Ray² of Mercer County Kentucky to Jesse Yocom in which Ray refers to Yocom as 'dear friend' and tells him about the pension act saying that if Yocom were still in Kentucky that he (Ray) and John Gritton³ could provide 'good evidence' of Yocom's service.
