Pension Application of Benjamin Edmondson (Edmundson) R13953 VA Half Pay Transcribed and annotated by C. Leon Harris and Fred Weyler. Revised 11 Dec 2023.

Pension Office September 7, 1842

I certify that on July 1838, half pay was allowed on the case of Benjamin Edmondson dec'd under the act of July 5, 1832. Entitled "An act to provide for the liquidating and paying certain claims of the State of Virginia," and that the half pay commenced on the 22^d of April 1783 when the revolutionary war terminated. It now appears that he left the service, having been a supernumerary officer, as early as the 6th of February 1782. The administrator heir of the said deceased Edmondson is therefore entitled to half pay on account of his service as a Lieutenant of the 2d Virginia State regiment from the 6th of February 1782 to the 22^d of April 1783 at the rate of one hundred and sixty dollars per annum. The amount is payable to Francis A Dickens, of Washington City, attorney of John M Gregory, of Virginia, administrator de bonis non of Benjamin Edmondson, deceased.

I Hamlin Willcox of the County of Charles City in the State of Virginia aged sixty six years in June last, do Certify that I was well acquainted with Benjamin Edmundson late of said County and State. That I lived within the distance of four miles of the residence of said Edmundson, had frequent transactions with him, and that said Benjamin Edmundson decd as well as I recollect, indeed I am Certain of it, between the last of March 1793, and the first of May following. The reason I can speak with such certainty, I acted as deputy Sheriff at the time and had process against said Edmundson in my hands at the time of his death. Given under my hand this 2nd day of August 1831. Hamlin Willcox

Virginia, In Charles City County Court the 20th day of April 1837

On the motion of William Edloe the Court doth Certify that it appears to the satisfaction of the Court by the oath of a Witness this day sworn and examined, that Benjamin Edmundson late of this County was a Lieutenant in the State line of Virginia, in the war of the Revolution; that the said Benjamin Edmundson died intestate without issue leaving a sister Elizabeth Edmundson who intermarried with Henry Edloe; That the said Elizabeth Edmundson was the only heir at Law of said Benjamin Edmundson; and that William Edloe is the only heir at Law of the said Elizabeth Edloe deceased'

Williamsburg Sept'r 12th 1837

From my earliest recollection I was induced to believe from the common talk of all my relatives that my uncle Benjamin Edmonson was a Lieut in the Va State Line that he fought a duel with a Brother officer by the name of Holmes and kill'd him he was advised by some friend to leave the army for fear of an arrest he did so but on reflection he returned to duty and rejoined his regiment again

W Edloe [William Edloe]

The Affidavit of Mrs. Margaret W. Munford aged Sixty three years October last taken before John Sinclair a Justice of the peace for the County of Gloucester. the said affiant not having been duly sworn, but having first solemnly affirmed (having religious scruples as to the taking of an Oath) declares as follows to wit. that she was well acquainted with Mr. Benjamin Edmondson of Weyanoake [Weyanoke] Charles City County Virginia that the said Edmondson was her Step Father having married her mother Margaret Harwood widow of Samuel Harwood of Weyanoake that she had frequently heard said Edmondson speak of his military services during the Revolutionary War that she believes from her own recolection and accounts of her late husband Robert Munford that the said Edmondson died in the year Seventeen hundred and ninety three, that the said Edmondson died about eight months previous to her mother whome she believes died in that year, but the death of her mother can be more fully ascertained by refference to the Will of mother which is recorded in County Court of Charles City and was written but two or three days previous to her death.
