[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Pension Office December 6, 1836

I certify that from an examination of the claim of the Heirs at Law of the late John Hardyman, deceased, I am satisfied that he was a Lieutenant in the second Regiment of Infantry belonging to the State of Virginia: that he served until the 6th of February 1782, when he became Supernumerary; that he died in the year 1808, in Elizabeth City County, Virginia: that the case is embraced by the provisions of the act of July 5, 1832, entitled "an act to provide for liquidating and paying certain claims of the State of Virginia:" that the claim should therefore be allowed at the rate of \$160 per annum from the 22nd of April 1783 when the war terminated to the first of January 1808, in which last mentioned year he died; and that the amount should be paid to his administrator Benjamin Harrison of Charles City County Virginia.

I certify that from an examination of the claim of the administrator of the late John Hardyman, deceased, who was a Lieutenant in the 2nd Va. State Regiment and find that he became supernumerary by the 6th February 1782, and that there is, consequently, due under the Act of Congress of the 5th of July 1832 entitled "the act to provide for liquidating and paying certain claims of the State of Virginia," half pay from that day to 22 April 1783, the date from which the claim was allowed on the 6th December 1836, and has heretofore been paid – And that it is my opinion that the claim should now be allowed at the rate of \$160 per annum from the 6th February 1782, to the 22nd of April 1783; and that the Amount is payable to Francis H Dickins Attorney of the Administrator, Joseph Segar [?] of Elizabeth City County Virginia, the Administrator of the estate of the said John Hardyman.

Pension Office July 10th, 1851

I certify that I have examined the Claim of the administrator of Captain John Hardyman

deceased under the act of 5th of July 1832, and find that he was appointed Captain of Marines, on the 16th February 1782, shortly after he had become a supernumerary Lieutenant in the land service in the State of Virginia, & that he served as such to the end of the War, & was therefore entitled to half pay as Captain of Marines, at the rate of \$240 per annum, from the 22nd day of April 1783 to the first day of January 1808, in which year he died, which sum, deducting the amounts heretofore paid, as Lieutenant of Infantry, is payable to Joseph Segar, the present administrator *de bonis non*, of said John Hardyman's Estate, and resident near Old Point Comfort Virginia.

The Affidavit of Ann Payne, taken and made before me Thomas C. Peek a Notary Public in and for the County of Elizabeth City this the 17th day of June 1851,

The said Ann Payne being duly Sworn deposeth and saith as follows: That she knew the said John Hardyman both during and after the revolutionary War, That the said John Hardyman died in this County of Elizabeth City Sometime 25 or 30 years after said War, –

That the said John Hardyman was several years engaged in the State Service in said war, both in the land and Naval Service, That in the latter part of the War to wit, in the year 1782, the said Hardyman recruited a company of Marines for the Navy of Virginia, —in and about Hampton

and served as Captain of said Company of Marines on board of the *Cormorant*², one of the Vessels of the Virginia Navy which was frequently anchored at an off Hampton, and continued to Serve as such until the Vessel was Sold "laid up about the end of the War; That she recollects distinctly having seen the said John Hardyman recruiting in and about Hampton, and has frequently seen him at Hampton, in company with other officers of the Navy, Among whom she recollects Captain Richard Baron, and Captain James Gray, Further This Affiant saith Not S/ Ann Payne, X her mark

As I expect a meeting of Captains Maxwell and Harris at this place on Friday the 16th Instant, I have to request your attendance on that day in order to make your return of Marines, which you have enlisted, you will be kind enough to order them all to this place immediately, or if more convenient, to Broadway's to go on board the *Cormorant*, for the present – When you meet here, the arrangement of the Officers, their wagons & privileges will be ascertained.

Sir.

As you are appointed Captain of Marines on board of the State Ship the *Cormorant*, commanded by James Maxwell Esquire & now at Baltimore, you'll please to proceed with the utmost expedition to recruit your company which is to consist of forty-seven besides your

² HARDYMAN, JOHN VA Captain of Marines, Virginia Marines John Hardyman apparently served in the 2nd Virginia State Regiment earlier in the war. In late 1781 or early 1782 [Stewart, 197. But presumably after May 1782, when the Navy was more or less re-established, see Paullin, 416] he was appointed as a Captain of Marines in the Virginia Marines and assigned to the Virginia Navy Ship *Cormorant* (Captain JAMES MAXWELL). With his Lieutenants JOHN CLARK, LEWIS WEBB, and SELDEN, he attempted to recruit Marines for the *Cormorant*, then lying at Hampton. [Stewart, 197] Hardyman was offering a bonus of \$5 for every able-bodied soldier who entered and \$10 for each recruit who had made one or more voyages to the West Indies or Europe. [Stewart, 122] Hardyman was presumably in service until the *Cormorant* was ordered sold in October 1782. Lieutenant. You are to enlist them for nine months or two cruises counting each cruise from the Sailing of the Ship and her return again into harbor in Virginia. You'll informed that men should any inquiry be made on the Subject, That they are to do duty either on shore or on board when the public Service relative to the Ship makes it necessary. –

Should any of them be turned over into Prizes in order to do duty there until the Prize arrived in port they are to consider themselves as still belonging to the Ship & be ready to go on board when she arrives.

Your pay shall commence from this date and you shall be indulged with such privileges merchandise as the burden of the Ship will permit which shall be hereafter Settled you are to appoint your sergeants yourself. You shall be allowed \$5 for every able-bodied Soldier you recruit, And \$10 for every able bodied man that has been one or more voyages in the West Indies or Europe. This in full for your Expenses.

The Marines shall receive pay at the rate of \$10 per month, and one months pay advanced to each before the Ship sails. I desire that you have each man Sworn as enlisted & that they also signed their enlistments. So soon as you have recruited 10 or 15 men, you'll please order them to a proper rendezvous and give me notice that I may order them to the Ship where they may be useful – I have appointed Mr. Clark a Lieutenant who is also on the recruiting business and you'll correspond with each other & have your men rendezvous at one place, I have delivered to you \$80 on Account – You'll Advise me from time to time the progress you make in recruiting.

February 12, 1783 a warrant was issued by the State of Virginia for 2666 acres of land.

He married Miss Hannah Harrison; died 1808 in Virginia City County, Virginia without issue. He had a brother Stith Hardyman, who died leaving a son Tyler Hardyman, and the latter died in Alabama leaving children.

He also had a sister, who married Peter Eppes, and the following children of this marriage were the only heirs of John Hardyman in 1836.

I was well acquainted with Major John Hardyman (who was called Major John) and uncle to Tyler Hardyman – That he rendered Military Services in the Revolutionary war, but cannot say in what grade, nor can I say, whether he left a Will, or an Heir, but that he married a Miss Hannah Harrison, and my belief is that he left no immediate Heir – I am respectfully your obedient Servant

In Charles City County Court the 21st day of July 1836

It appears to the Court from satisfactory evidence that John Hardyman formerly of Charles City County and who was a Lieutenant of the 2nd State Regiment in the Virginia line in the Revolutionary war died in Elizabeth City County without issue leaving as his heir at law his brother Stith Hardyman and one sister (name not known who intermarried with Peter Eppes) That Stith Hardyman died leaving as his heirs at law his son Tyler Hardyman who recently died in Alabama leaving several Children; that Peter Eppes by the above marriage had the following children viz. John Eppes who left two children George and Lucy, Peter Eppes who died leaving two children William and John; Sarah J Eppes, Mary Eppes, Lucy B Eppes who intermarried with Richard Williams and Angelica Eppes who intermarried with Sampson Jones. So that the children of the said Tyler Hardyman deceased, and the descendents of the said Peter Eppes are the only heirs at Law of the said John Hardyman a Lieutenant as aforesaid – And the Court further certifies that administration is granted to Benjamin Harrison to recover the half pay of the said Lieutenant John Hardyman with the Consent of such of the Heirs of Said Hardyman as our Capable in Law of giving consent.

The undersigned, one of the Heirs at Law of John Hardyman, formerly of Charles City County, Virginia, which said Hardyman she has always heard & understood & verily believes, was an officer of the Virginia State Line in the Revolutionary War, respectfully in her own behalf & of the other heirs of said Hardyman, solicits of the Treasury Department at Washington the small allowance of half pay under the act of Congress of July 1832 the same having been never received.

With respect to the services of said John Hardyman, she can state nothing of her own knowledge. She has always heard & is now informed by persons conversant with the records, that he was engaged in the State service as an officer in the War of the Revolution served faithfully as such & this she believes, having reasons for such belief & none to the contrary. But she will not & cannot state anything of her own knowledge, nor anything more than she has heard & been informed.

She also certifies that the other heirs of said John Hardyman reside in the following places viz. – Lucy B Williams in the Town of Lynchburg – Angelica Jones in the City of Richmond – this deponent, Sarah T Eppes, Mary Eppes, John & William Eppes reside in the City of Richmond & George & Lucy Eppes in Henrico County, Virginia
