Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia State Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 10th day of September 1783, in the name of James Kennedy, as a Lieutenant & Adjutant for £171.16.0, which Certificate appears to have been delivered to and was given for services prior to the 1st January 1782.

I certify that I have examined the claim of the administrator of James Kennedy, deceased, who asked for half pay for the service of said Kennedy as Adjutant in the Virginia State Garrison

Regiment, half pay as Lieutenant having been already allowed, and I find that under the act of the 5 July 1832, and the decision of the Department of the Interior in the case of William Graves, he is entitled to his \$6.50 per month for Kennedy service as Adjutant from the 6th of February 1781 to the 10th of March 1828: and that the amount is payable to Granville Kennedy of Henrico County Virginia, administrator of James Kennedy, deceased: to be paid in drafts at New York in favor of said Kennedy, one for the 3rd of the amount, and the other for two thirds of the amount, to be sent to him from Stanardsville, Virginia.

To the Legislature of Virginia

The petition and Memorial of Albert Kennedy, Nancy Kennedy, Granville Kennedy, Elizabeth Kennedy, Charles Kennedy, George Kennedy, Barbara Kennedy, and Washington Kennedy, respectfully represents to your Honourable body, that they are the heirs and legal representatives of James Kennedy deceased that the said James Kennedy enlisted in the Army of the Revolution in the Virginia State line, that the said James Kennedy was promoted to the rank of Lieutenant and continued in service to the close of the War. That the said James Kennedy was promised by the Government after he became a supernumerary Officer half pay for life, upon condition that he would continue to hold his commission and to render service when demanded of him by the Government to the end of the War, which condition was fully complied with by the said James Kennedy, which will fully appear by reference to the evidence here with filed.

Your petitioners beg leave further to represent that the said James Kennedy during his lifetime never received the promised rewards for services rendered either in half pay, commutation pay, or any other consideration whatever.

Your petitioners therefore pray that your Honourable body will allow them the commutation of five years full pay in lieu of half pay for life. Your petitioners appeal with confidence to that Justice and liberality which has heretofore Governed the Legislature in extending to them the same relief and measure of Justice, which has been extended to others under similar circumstances.

Heirs of James Kennedy December 23rd 1829 Referred to R. C. [Revolutionary Claims]

Louisa County to wit

This is to certify that James Chambours [sic, James Chambers]² of the County aforesaid, personally appeared before me a Justice of the peace for said County and made oath that he was well acquainted with James Kennedy an officer in the Virginia State line and served under him, he being Lieutenant and Adjutant in the Spring of the year 1777 and saw him at Sundry times between that time and the 29th of May 1780 and served under him, alternately until the defeat of Col. Beautorts [Abraham Buford, Battle of the Waxhaws, May 29, 1780] at which time he the said Chambours was severely wounded, he likewise saw him in service when General Lafayette's Army passed through Louisa County to the point of fork, and that he believes that the said Kennedy served to the end of the revolutionary war, that he has frequently heard him the said Kennedy say so himself.

This day appeared before me in the County aforesaid a Justice of the peace in said County, Martin Kennedy of the County of Hanover & made oath that he was intimately acquainted with James Kennedy during the Revolutionary War & that the aforesaid James Kennedy did serve throughout the War.
