Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Commissioner of Pensions Dear Sir,

You will no doubt recollect from the record the application of Michael Shaver in right of his Father Ensign Michael Shaver, who was killed in Gates Defeat, for seven years half pay, that case has lain a long time on hand, and in consequence of [words too faint to discern] the result in the department, I Requested Mr. R. H. Gallaher to take the case before Congress, a year ago, It has not yet been done, all the papers were filed, and if Mr. Gallaher has not withdrawn the papers, I would be pleased if the Department would act on the case, the case is a plain and clear 1. If you will turn to the Resolution of Congress of 15th May 1778, the Case is clearly established and we pray it may be granted, in truth it all to be.

I beg to know if the Declaration and proof of Michael, Son of Ensign Michael Shaver, who was killed in Gates Defeat, are on file in the Pension Office, Mr. Shaver made application for seven Years Half Pay under Act of 1780, in right of his Father, and really [?], I at this moment forget, whether I sent the papers to the pension Office or to the Honorable McMullin² to bring

August 24, 1853

Judges present: John Eakin, Abram F. Bradley and Reuben Widener

Gent: Michael Shaver, son and one of the heirs of Michael Shaver deceased, personally appeared in court and subscribed and made oath to a declaration, in order to obtain the benefits of the resolutions and act of Congress passed in the year 1783, wherein it is provided, that if an officer is killed or dies in the line of duty, his heirs may claim and obtain seven years half pay and claim and obtain one hundred fifty acres of bounty land. And the Court doth certify that they believe the said Michael Shaver to be the son and one of the heirs of Michael Shaver, deceased, who was an Ensign in the war of the Revolution and killed at the Battle of Camden in the year 1780. And the Court doth further certify that David Shaver who lately resided in the County of Sullivan, State of Tennessee is also a son of the said Michael Shaver, deceased, and that the said Michael and David are the only two children of the said Michael Shaver, deceased who are now living.
