Acted July 5, 1832 Claim for commutation Robert W Spencer Son & heir at law of John Spencer deceased And Ensign or Lieutenant and Virginia State Line in Rev. War Power of attorney to ascertain if Commutation be due &c.

Know all men by these presents; that I Robert W Spencer of Halifax County in the State of Virginia, Son, of John Spencer, disease, who was an officer in the Revolutionary War, and who continued in service to the end of the War do hereby constitute and appoint James Garden of Charlotte County Virginia my true and lawful attorney for me and in my name and a half, and I also authorize said Garden to employ an assistant at his own discretion to prosecute in the United States Court of Claims and before Congress and the Department of the Interior, my claim for a pension for services rendered by my deceased Father, the above mentioned John Spencer in the Revolutionary War. His power of Attorney to be irrevocable for the term of 5 years from date. Witness my hand and seal this 17th day of February 1857.

[From rejected claims in the Library of Virginia.]

I do hereby Certify that I held a Lieutenat's commission in the Virginia State Regiment of Artillery Commanded by Colo Thomas Marshall raised during the Revelutionary War for three years and that John Spencer did inlist in said Reg't as a Soldier and in consequence of said Spencer having served two years pryor to that period in Seventh Virginia Reg't raised on Continental Establishment and from his Integrity and good conduct in Colo Thomas Marshall's Reg't he was appointed a Lieutenant in said Reg't and received his Commission as such; and did serve untill the said Reg't was Discharged. Given from under my hand this 25th day of March 1818.
