The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To Augustin Tabb, a Captain in the 2<sup>nd</sup> the State Regiment in the Virginia Line, (commanded by Colonel William Brent) in the Revolutionary War.

For his half pay, from 3<sup>rd</sup> September 1783, (date of Treaty of Peace) to 18<sup>th</sup> December 1792, (date of his death) in pursuance of the 3<sup>rd</sup> Section of an act of Congress "to provide for liquidating and paying certain claims of the State of Virginia," approved 5<sup>th</sup> July, 1832, being 9 years and 107 days, at £72 – Virginia currency, equal to \$240 per annum, to dollars 2230.36/100.

Case of Augustin Tabb

The name of Augustin Tabb is on the List of "Names not presented," received from Auditor Heath, as a Captain in service, in the 2nd Regiment, (which was commanded by Colonel William Brent – Charles Dabney being a Lieutenant Colonel thereof) at £72 per annum half pay.

By the documents herewith his identity and the date of his death 18th of December 1792 appears satisfactorily proved – that he died intestate, & Thomas Cary is the Administrator *de bonis non* on his Estate appointed 4th of March 1832.

It appears that he left three children, viz. Edmund by his first wife, Fanny & Austin by his last wife, that Austin died an infant, & that Fanny married Thomas Cary – And it further appears that Edmund Tabb, by will dated 12 April 1815, bequeathed all his property to said Thomas Cary, (the husband of his sister Fanny) and that after his absence for more than seven years without being heard from, the said will was admitted to record by decree of Court at Gloucester County, of 25th of October 1831.

From all which it appears that Thomas Cary is entitled to receive the amount of half pay

To Samuel Cary a supernumerary Lieutenant in the 2nd State Regiment in the Virginia Line (commanded by Colonel William Brent) in the Revolutionary War.

For his half pay, from 6 February, 1781, (day after reduction of State Troops) to 4th of November 1805, in pursuance of the 3rd section of the act of Congress "to provide for liquidating and paying certain claims of the State of Virginia," approved 5th of July, 1832, being 24 years 272 days at £48 – Virginia Currency, equal to \$106 per annum, amounting to him 3959.23.

I certify that I have examined the claim of the administrator of the late Augustin Tabb, who was a Captain in the 2nd Virginia State Regiment of Infantry, and I find that under the act of July 5, 1832, half pay was allowed from the 3rd September 1783. Half pay is now claimed from the 13th of April 1782, when he left the service, to the 3rd September 1783. My opinion is that the claim should be allowed. I therefore certify that half pay is still do you for the time claimed at the rate of \$240 per annum and that the amount is payable to Thomas L. Smith, attorney of John R Cary, administrator of said Tabb, deceased.
