I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Sir -

I beg herewith two present the claim of my Grandfather, Samuel Timpson for his commutation and interest in lieu of his half pay for life heretofore received, and adjusted on the 10th of March A.D. 1834: the evidence to which I respectfully refer you is filed in the Register's Office Treasury Department, showing that he served until the end of the War.

The enclosed copy of settlement, certified by the Register will show that his half pay was adjusted from the 22nd April A.D. 1783 until his death which occurred on the 16th of January A.D. 1814.

To Samuel Timpson, a Captain of Artillery in the Virginia Line in the Revolutionary War for his half pay from 22nd April 1783 to the 15th of January 1814 in pursuance of the third Section of an act of Congress to provide for liquidating and paying certain claims of the State of Virginia, approved the 15th of July 1832, being 30 years 269 days at £90, Virginia Currency, equal to \$300 per annum, amounting to \$9221.10.

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia State Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 23rd day of February 1784, in the name of Samuel Timpson as Captain of Artillery for £290.17.0, which Certificate appears to have been delivered to himself and was given for services prior to the 1st January 1782.

Given under my hand, at the Auditor's Office, Richmond, this 10th day of February 1834.
