[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Halifax County SS

On this 30<sup>th</sup> day of March 1843 personally appeared before me John H. Thrower one of the Acting Magistrates and a member of the Court of Pleas and Quarter Sessions in and for said County Frances Bachelor a resident of said County and State aged 85 years who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 4<sup>th</sup> 1836, And the Act explanatory of said Act passed March 3<sup>rd</sup> 1837, granting pensions to certain widows, that she is the widow of William Wooten who was a private soldier in the Army of the revolution for the term of Eighteen months. She further declares that she was married to the said William Wooten in the fall of the year 1777. That her husband the aforesaid William Wooten died on the first day of January 1803.

That she afterwards married to William Bachelor who died on the 12<sup>th</sup> day of July 1820 and that she was a widow on the 4<sup>th</sup> of July 1836 and still remains a widow as will more fully appear by reference to the proof hereunto annexed.

State of North Carolina, Halifax County May Term 1843

By James Simmons Clerk of the Pleas & Quarter Sessions, and keeper of the public records of said County, certify that Frances Bachelor the widow of William Bachelor who died on the 12<sup>th</sup> day of July 1820.

I also certify that it is the opinion of the Court that the said Bachelor and William Wooten were both Soldiers of the Revolution, and it is proved before this Court that William Wooten was a Soldier and served as such for 18 months at the least. Satisfactory evidence has also been addressed in Court and proved that Frances Bachelor is the widow of William Bachelor who was a Soldier of the Revolution. Whereof it is ordered by said Court that the Clerk certify the same to the War Department. In testimony thereof by James Simmons Clerk as aforesaid Certify the foregoing is a true and exact Copy of Francis Bash was at application for a Pension.

On this 14<sup>th</sup> day of May A.D. 1853 personally appeared before me Elizabeth Jones who being duly sworn according to law declares that she is the daughter of Frances Bachelor formally widow of William Wooten who applied for a pension under Act of 4<sup>th</sup> of July 1836 which has not yet been allowed, that her mother died on the 19<sup>th</sup> day of August A.D. 1843 and she hereby appoints J. H. G. McCutchen of Washington City her Attorney to prosecute her claim to the pension of her mother and hereby request that the same may be allowed and paid at Washington, DC.
