Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky, County of Monroe

On this 13th day of June A.D. 1851 Before me Parish Sims – an acting Justice of the Peace in and for the County and State above mentioned personally appeared Hiram Bailey & Archibald McMillan, residents of Monroe County, who being first duly sworn according to law, do on their Oath make the following declaration, To wit: That the annexed leaf is the genuine family Record of William Bailey deceased late of Monroe County and State of Kentucky. That the old family Bible from which the leaf was taken, was kept in the family of William Bailey aforesaid until the time of his death. That we have often seen the Bible whilst in his family and certify that it contained the identical family Record which is hereto annexed, the Bible, remained with the widow Elizabeth Bailey until the time of her death, in Jackson County Tennessee, and is now to be found in the same house where she died – they also Certify that the aforesaid William Bailey died in Monroe County Kentucky on the eighth day of February A.D. 1829 being about 80 years of age. That his widow Elizabeth Bailey aforesaid died in Jackson County, Tennessee, on the 20th day of August A.D. 1849, at the age of about 90 years. That the following all the only surviving children of the aforesaid William Bailey deceased and Elizabeth Bailey deceased to wit – Sarah Waddle aged 68 years, Elizabeth Porter aged 63 years – William Bailey aged 57 years, Martin Bailey aged 55 years, Susanna Boile aged 53 years, and Bennett Bailey aged 48 years. They also certify that they believe that the said William Bailey was a soldier in the Revolutionary War having frequently heard him and others speak of his military services. They also state that they are disinterested witnesses. -- and that they believe the entries on the annexed family record are in the hand writing of William Bailey deceased.

On this 28th day of June 1852 Martin Bailey of the County and State aforesaid being first duly sworn according to law declares and saith – That he is the Administrator of the Estate of his Mother Elizabeth Bailey deceased late of the County and State aforesaid, and widow of William Bailey deceased late of Monroe County aforesaid and formerly a soldier of the Revolution in the State of North Carolina, and he further states, That the said William Bailey died in Monroe County, in the year 1832 at the age of about 88 years – leaving Elizabeth Bailey his widow; who remained his widow until the 19th day of August, 1849 when she died in Jackson County and State of Tennessee, during a temporary absence from her home in Monroe County, Kentucky, being about 90 years at the time of her death, Leaving the following named surviving children who are her only surviving children To wit, Sarah Waddle, Elizabeth Porter, William Bailey – Martin Bailey – Susannah Boyles – and Bennett H. Bailey all of whom are still living – Said Affiant further declares and saith as – That his Father the said William Bailey was generally reputed and believed in his lifetime to have been a soldier in the Revolution, in the State line of North Carolina, That he remembers well remembers to have heard him speak of his services and suffering in the war – and that he served about five years, or the greater part of the war, also that he fought at the battles of Kings Mountain, Eutaw Springs, battles of Cowpens and at the Shallow Fords of Yacht [sic, Yadkin River] and various other battles and engagements the names of which he has forgotten. It is hereby ordered to be certified that satisfactory evidence has been presented to said Court now in session, That William Bailey late of Monroe County and State of Kentucky who in his lifetime was generally reputed and believed to have been a Soldier in the Revolution in the State line of North Carolina died in said County of Monroe in the year 1832 at the age of 88 years leaving Elizabeth Bailey his widow who survived him and remained his widow never having again married until the 19th of August 1849 when she also died in Jackson County and State of Tennessee at the age of about 90 years leaving the following named surviving children who are her only surviving children to wit Sarah Waddle, Elizabeth Porter, William Bailey, Martin Bailey, Susanna Boyles, and Bennett Bailey, all of whom are still living.
