Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Missouri Osage County

On this 5th day of May 1846 Personally appeared before the undersigned Justice of the Peace in Osage County Rachel Laughlin aged Seventy four years who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the Provision made by the Act of Congress passed July 7th 1838 Entitled "An Act granting half pay and Pensions to certain widows." That she is the widow of James Laughlin who was a Private in the Army of the Revolution and Died in Caldwell County Kentucky in August 1816. That he never received a Pension. That she believes he was in the Militia most of the time --[several words obscured by a fold in the paper] that she was married to the said James Laughlin on the 24th of February 1791 in Pendleton County South Carolina. That he was at several Battles, Briar Creek,¹ Hanging Rock,² Rocky Mount,³ Eutaw Springs⁴ and was drafted once she thinks & volunteered at other times was a Private most of the time but states he was a Lieutenant about 6 months his officers she believes were Capt. Adam Meek Col. John Moffett Genl. Sumpter [sic, Thomas Sumter] for part of the time he was out at different times through most of the war and she does not remember all the officers names. He volunteered once at York South Carolina and served some in North Carolina & some in Georgia -- she was not acquainted with him until after the war do not know whether he ever had a discharge or not. Capt. A. Meek is one of the captains she remembers the name of and Col. J. Moffett & Genl. Sumter -- Col. McColl -she believes the foregoing to be true of what she knows and of what she has been informed of she believes to be true -- That she never has received any Pension. That she is still the widow of said James Laughlin ____ -- She further says that she is not able to [attend] court on the account of a bodily disease.

[p 4: On November 28, 1846 in Sangamon County, Illinois, Mary Drennan, wife of William Drennan, Sr., gave testimony that she is 73 years of age in January next; that she formerly lived in Pendleton district South Carolina; that she lived about three miles from Mr. Dalrymple's, Rachel Laughlin's father, in Pendleton District South Carolina in the year 1790; that affiant and Rachel Dalrymple were "girls together"; that she distinctly remembers seeing James Laughlin and Rachel Dalrymple married in 1791; that she was very well acquainted with Samuel Dalrymple, Rachel's father; and that Rachel and James had 10 children [named below]; and that she Mary the affiant had 12 children [not named]. She signed her affidavit with her mark.]

[pp 43-45: Is an affidavit dated Nov. 28, 1846 given in Sangamon County, Illinois by William Drennan, 78 next April, given in support of the widow's application. Anyone interested in the Drennan family would find this affidavit interesting because of the affiant's details of his own life and marriage to Mary Thomas "with whom he still lives."

[Facts in file: The veteran and his wife had ten children: Samuel, John M., Polly, Sally, James the fifth child born about 1805, William, Joseph, Nancy, Betsey and Robert. In 1846 a number of these children were living in Illinois near Springfield, which ones not stated. The widow's claim was not allowed because she failed to prove her husband served at least six months as required by the pension law.]
