[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Georgia Gwinnett County: Superior Court September Term 1832

On this 25th day of September 1832 personally appeared in open Court (it being a Court of record) now sitting Matthew McRight a resident of the said County of Gwinnett & State of Georgia aged Seventy years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. That he entered the service of the United States under the following named officers and served as herein stated. That he entered the service in Fairfield District South Carolina wherein he then resided in the year 1781 or 1782 under Capt. James Craig Lieut. Nimrod Mitchell and William Smith as a drafted militia man for the term of two months was attached to the command of General Sumpter [sic, Thomas Sumter] was stationed near Stono & Bigum Church [sic, Biggin Church], afterwards was drafted & served one other tour of two months on the Congarees [sic, Congaree River] under the same officers & one other tour under the same officers against the British at Orangeburg of one month, afterwards drafted again & went under the same officers and stationed at the four holes Bridge under Col. Bratton [William Bratton] for two months, drafted again for one month under the same Company officers but attached to Col. Taylor's [Thomas Taylor's] Regiment at the time of the battle of the Eutaw Springs [September 8, 1781] & one other tour of one month under General Green [sic, Nathanael Greene] all these several tours served in South Carolina & was discharged from each of the aforesaid tours by his officers but never took a written discharge from any of them was on duty from the time he was first called into service whenever called on until peace was made, that after the Revolutionary War that he lived in Fairfield District South Carolina from thence to the State of Georgia in the County of Elbert from thence to Jackson County in said State & from thence to the County of Gwinnett & State of Georgia where he now resides and that he has no documentary evidence whereby he can prove his said services -- and that he knows of no person now living whose testimony he can procure who can testify to his services except Owen Andrews whose certificate & affidavit is herewith submitted. He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares his name is not on the pension roll of the agency of any State.

Georgia Gwinnett County: Before me the undersigned a Justice of the peace of said County personally appeared Owen Andrews and being duly sworn deposeth & saith that as well as he can now recollect the time he was in the year 1781 acquainted with Matthew McWright late of said County deceased that said McWright was then a private soldier attached to Col. Thomas Taylor's command in this State of South Carolina also that at the time of his first knowledge of said McWright he said McWright was stationed at or near Biggin Church -- but cannot say how long he remained in service at that time -- That he also knows that said McWright was in the service at the time of the Battle of Eutaw Springs which was in the same year to the best of his recollection. He knows that in that year & the next 1782 said McWright was in the service a great portion of his -- that they both resided in Fairfield District South Carolina at the time of each service & that said Matthew entered the service there -- deponent cannot possibly designate the length of each tour but from his knowledge of the service of said McWright he must have served at least 6 months and is of the opinion that he served much more than that length of time - and was never reputed and excellent soldier -- he being one of the Irish who had emigrated to this Country.

Georgia Gwinnett County: Before me the undersigned a Justice of the peace of said County personally appeared Bluford McWright of said County son of Matthew McWright late of said County deceased and being duly sworn in order to amend the Pension declaration of the said Matthew deposeth as follows to wit that he has always heard the said deceased up to the time of his death in November last said that he had served as much as 10 months as a private soldier in the Revolutionary War in the State of South Carolina -- that from his deceased statement he entered the service in Fairfield District South Carolina each time & that his services were rendered in the areas parts of that State and that the time he first entered was in the year 1781 and the whole services were rendered in the year 1781 & 1782 -- deponent further saith that his brother James McWright has in his possession a record of the age of the said deceased which shows that he was born in Antrim County Ireland on the 2nd day of February 1762 -- That John S. Wilson a clergyman & George M. Gresham who have testified Jourdan Ginn -- Elijah Winn Esquire & William Hamilton Esquire were all well acquainted with the character of the said deceased and day & many others of his neighbors can testify to their belief of his services as a soldier of the revolution & of his character for truth & veracity.
