[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

That your Petitioner spent the prime of his Life in the defense of the Country against the enemies in the Revolutionary war besides losing his property and having become old and infirm (being more than Seventy five years of age) and not wishing to become chargeable to the District but being fully confident that on account of the services he has rendered to the Country and the difficulties he has gone through & the sufferings he underwent in defense of his Country he is entitled to the gratitude of his Country.

Therefore your Petitioner prays that your Honorable Body will take his case into consideration and grant such relief as to Justice & the State of the case doth belong and your petitioner as in duty bound shall pray.

Before me Chas. J. Colcock one of the Judges of the State personally appeared John McWaters and being duly sworn makes oath that he enlisted as Sergeant in the ten months service Capt. John McCord's [John McCloud's] Company of Cavalry Col. Wade Hampton's Regiment and the Brigade commanded by General Thomas Sumter in the month of April or May in the year 1781 and that he continued to serve in said service until the expiration of the term of enlistment when he was regularly discharged at Orangeburg in March 1782 by order of Col. Middleton [Charles S. Myddleton] then commandant. That he the deponent was in the following engagements to wit the Hanging Rock, Rocky Mount, Fish dam Ford, Blackstock's, whilst in





[p 10: Priscilla McWaters petitioned the State of SC for a widow's pension saying that her husband John McWaters died in Fairfield District in August 1828 [August 31, 1828, according to James McWaters]; she signed her application with her mark.]

[p 3: In Fairfield District, SC on April 11, 1857, John McWaters, 64, filed a claim under the 1836 act stating that he is the son and one of the heirs at law of Priscilla McWaters deceased, widow of John McWaters "... who as this declarant has been informed & verily believes entered the service of the United States under the following named Officers, and served as herein after stated in the War of the Revolution: That during the war of the Revolution his said father resided in the State of South Carolina in the present District of Fairfield and entered the militia under the command of Capt. Joseph Howe & Lieut. John Steel & John Kincaid under the command of Col. William Bratton & served as Sergeant of Cavalry in the militia of this State nearly five months: That he also served as Sergeant under Capt. John McCord [John McCloud?] in the year 1780 and in the Spring of 1781 as a Sergeant of Cavalry for ten months under Capt. Francis Moore in Myddleton's [Charles Myddleton's] Regiment Sumter's Brigade of State Troops in the spring of 1782. That he was in the following battles namely Rocky Mount, Hanging Rock in 1780, Fish dam Ford, Blackstock's & Juniper Springs in what were then called "Sumter's Rounds" in this State during the years 1780, 1781 & 1782: that of his Comrades were John Hollis & Jesse Gladden late of this District. That he continued to reside in said District in said state until the year 1821 was allowed a pension by the Legislature of this State which he continued to draw till the year 1828 – when he died & in the year 1831 his said mother said Priscilla McWaters who had married his father just before he left said service was allowed a pension by said State which she continued to receive as his widow until just before her death in said District & State which took place on the second day of September 1841. That there are only this deponent & his brother James McWaters & his sister Polly Moore of Chester District in this State of the children of said father & mother known to be now living. That neither of his said parents ever received any pension from the United States & that their family record showing the exact date of their marriage these children cannot now produce it having been lost or carried off by some members of the family, and that there were no public registration of marriage regulated by law in this State as deponent has been informed & believes at the time of the marriage of his said parents...."





To the Honorable the Legislature of South Carolina

The humble petition of John McWalter Sheweth to your Honorable body that he was a Soldier in the Revolutionary War, he served nine months in Captain Hawkins [Dennis Hawkins?] Company of Colonel Stewart's [Lt. Col. John Stewart's] Regiment of minute man, in the year '76. He afterwards enlisted in Captain John McCord's Company of Colonel Middleton's Regiment of State Troops, and served ten months in the year '80. Your Petitioner has been

Concerned in twelve hard-fought battles besides others of minor importance, in which he has received three wounds. Part of the services of your petitioner was rendered in the Capacity of Sergeant. He has now buffeted the difficulties of 83 winters, and at the close of a long life the prime of which was spent in the service of his Country, he finds himself in abject poverty, and want of all the conveniences and many of the necessities of Life. Your Petitioner begs leave to observe that for a few years he has received from the State a pension, but from limited amount, and the bitter inability of your petitioner to exert himself for his own support, finds himself reduced to great want. He therefor prays that arrearages of pension may be paid him or that his pension may be so increased so as to enable him to close his few remaining days in P. And your petitioner as in duty bound will ever pray.

That the said John McWaters departed this Life in Fairfield District in August 1828. At which time certain arrears of his pension were then due him from the State.

Your petitioner is in very advanced Life – in a State of abject poverty and looks to the Legislature with confidence as the Soldier's widow for a continuation of that bounty.

Your Petitioner therefor prays that she may be entitled to receive such arrears of pension from the proper officer, as were due to her said Husband at the time of his death, there being no administration Granted of the few inconsiderable Effects which belonged to him and further that She may be in consideration of the facts above stated be permitted to receive from the State the Amount of pension given to her Husband for and during the few remaining years of her Life, and that she be allowed one years past pension.
