Pension application of William Rickles (Rickels) R8790 Mary f19VA Transcribed by Will Graves 6/28/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky County of Campbell: SS

On this 22nd day of January 1844 personally appeared in open Court, before the County Court of Campbell County, now sitting, William Rickles a resident of the town of Newport in the County of Campbell and State of Kentucky aged about eighty-three years, who, being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. —

He entered the service of the United States under the following named officers and served as herein stated – that he was drafted into the service states in the Company of Joseph Morton, Captain of which Company John Terrell was the 1st Sergeant, Killand McGran was the Drummer and he recollects of the privates in that Company the names of John Harris, Joseph Harris, William Hooker, James Dennam, Namen Roberts, Samuel Hues and Joseph Clark – that at the time he entered into the service he resided in the County of Pittsylvania, State of Virginia, where he continued to reside until he removed to the State of Kentucky near fifty years ago - & has continued to reside in the State of Kentucky ever since – that he was at the battle of Guilford [March 15, 1781] to which place he marched, but has little or no recollection of the country through which he passed from Pittsylvania to that place – that he was drafted into the service – that he did not know & does not recollect any of the officers in the Regular service except General Greene [Nathanael Greene] who commanded the Army & does not remember by any particular designation any of the Continental regiments or companies with which he served – that he had a discharge & gave it to his father, who has been dead about thirty years & he does not know what has become of it & is now not in possession of any documentary evidence & that he knows of no person, whose testimony he can procure, who can testify to his service – that he was called out for six months & remained in service until General Greene discharged his Captain – that he resides in the town of Newport, County of Campbell & State of Kentucky & has resided in said town for many years – that he is known in said town to General James Taylor, Richard Southgate, Esquire, James D Anderson and others, who can testify to his character for veracity, & their belief of his services as a soldier of the Revolution.

He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the Pension Roll of the Agency of any State.


