Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

And he Court held for Norfolk County the 21 day of October 1850

The Court doth certify upon satisfactory evidence produced before it, that John Rose who was a soldier in the War of the Revolution died leaving three children Nancy, John and Jane, that John the son died leaving no children but left as his heirs at law his sister Nancy and Jane his heirs at law that the said Nancy is the widow of Robert Powers. And that the said Nancy Powers and Jane Rice are now living.

I Arthur Emerson Clerk of the County Court of Norfolk County in the State of Virginia aforesaid do hereby certify that the foregoing is a true copy from the records of the said Court.

In testimony thereof I have hereunto set my hand and affixed the seal of said Court, this 16th day of May 1854 in the 78th year of the Commonwealth.

Personally appeared before me James Baker a Notary Public for the City of Norfolk State of Virginia, Miss Jeany Rose who upon oath deposes as follows. That she well knew that John Rose was in the Revolutionary Army. That he entered the Army at the Beginning of the Revolution, & continued in it to the end of the War & received an honorable discharge which said deponent has often seen & that after his death it could be found – said deponent states that John Rose was married to Mary Addison at Accomack Virginia in the year 1788 July 2nd. That John Rose died in Princess Anne County Virginia in the year 1817 11th of November, and that his wife Mary, died in the same County in the year 1826, 16th day of January. And that the age Jeany Rose is 65 years. Done & subscribed before me in Norfolk City this 16th day of August 1854.

Personally appeared before me James Baker a Notary Public for the City of Norfolk, State of Virginia Mrs. Mary Howel who upon oath depose as follows. That she [was] well acquainted with the Late John Rose. He and her father William Fisher were both in the Revolutionary War together. This deponent states that they both entered the Revolutionary War at the same time from the neighborhood of Accomack Virginia, at the commencement of the Revolution & continued therein throughout the whole war. – She said deponent states that Mr. Rose married Mary Addison at Accomack Virginia in the year 1788 July 2nd. That John Rose died in the year 1817, 11th November in Princess Anne County Virginia and his wife Mary died in the same County in the year 1825, 16th January.
