Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Personally appeared in open Court before us Henry Miller Chairman, and William A
Darden & Wyatt Moye Justices of the said Court Henry Sauls of the County and State aforesaid
and being first duly sworn deposeth and saith that some short time before Lord Cornwallis's
army marched through North Carolina on their way South, he was drafted, and organized as a
Private at Kinston Lenoir County (then called Dobbs) in this State aforesaid under Benjamin Exum,
Colonel Commandant, and General Richard Caswell – marched thence near Fayetteville, was
there about a week – marched thence South – near Camden in South Carolina, joined General
Gates's [Horatio Gates'] Army – was in the Battle at Camden [Battle of Camden, August 15-16,
1780] – was in the service altogether about three months.
