## Southern Campaign American Revolution Pension Statements & Rosters

Pension application of Thomas Saunders (Sanders) R9216 Mary f46VA Transcribed by Will Graves 1/13/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

## State of Kentucky Bullitt County to wit

On this 7th day of January 1846 personally appeared before me, David L Brooks a Justice of the Peace (Magistrate) in the County of Bullitt & State of Kentucky, Mary Sanders a resident of Bullitt County Kentucky aged eighty-seven years on the 5th day of December last – who being first duly sworn, according to law doth on her oath make the following declaration in order to obtain the benefit of the provisions made by the act of Congress passed July 7th 1838 entitled "an act granting half pay and pensions to certain widows." That she is the widow of Thomas Sanders deceased that said Thomas Sanders entered the service of the United States in the Army of the Revolution as a private (and she has understood he served afterwards as corporal) in the County of Fauquier and State of Virginia on the \_\_ day of\_\_ in 1776 – or about that time – she thinks in Captain \_\_ Harrison's company under Colonel \_\_ Temple in a horse Company or Regiment – and that she believes he served in the Army of the revolution Continental service two or three years – she cannot say certainly but believes it was three years or nearly so, she cannot say what battles he was in – He is believed to have served in the Light horse – She is getting old and does not now recollect the nature of his service. She refers to the rolls from Virginia & at the war department for the nature and length of his service – she confidently believes his name is registered on the Rolls of the Revolutionary Army and the length & nature of service is there given. She does not know anyone now living by whom she could prove his service – She states that if Joseph Saunders was living (who was an officer a Lieutenant [she] believes, she could prove the service by him. He was a pensioner). She cannot state the time he left the Service – not now recollect the dates from old age & Infirmity on this subject – She does not know whether he was drafted or was a volunteer – or substitute – She states she has been informed and believes the name of her husband is enrolled on the War Department roll [?] shew his Services (from Virginia) that the said Thomas Sanders died in Bullitt County Kentucky on the 3rd January 1832. She further states that she was married to the said Thomas Sanders on the 2nd day of June 1785 by Robert Sanders of Fauquier County Virginia – and that her husband the aforesaid Thomas Sanders deceased as aforesaid on the 3 January 1832. That she was not married to him prior to his leaving the service, but the marriage took place as aforesaid previous to the 1st of January 1794. She states the family Bible here sent contains the Record of the marriage & death of the parties aforesaid – that the same has remained in my possession since it was wrote – and I know the record of the facts of the marriages & debts as therein named are true – She does not now recollect in whose hand write [handwriting] the said marriage record is in – someone of the older family relatives – she states she is wholly unable from old age & infirmity to attend Court

Thomas Sanders departed this life January 3rd 1832

Sally Gore departed this life November 14th 1834 after [one or more indecipherable words, too faint to discern] 6 weeks of Consumption

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 16th day of April 1785, in the name of Thomas Saunders as a Soldier of Infantry for £49.19.6, which Certificate appears to have been delivered to himself and was given for services prior to the 1<sup>st</sup> January 1782.

Given under my hand, at the Auditor's Office, Richmond, this 3rd day of February 1846.
