Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Tennessee Robertson County: Be it known that before me Thomas Farmer an acting Justice of the Peace for the County & State aforesaid personally appeared William Scott a resident of Philips County Arkansas aged sixty-five years who being sworn duly doth on his oath make the following statement, that he is the son of William Scott who was in the Virginia line of the revolution as he has been informed during the whole war most of the time in the character of a Drummer. That he died in the year 1801 & on the 21st day of April leaving Affiant's Mother Hannah Scott as his widow that his father and mother were married in the year 1780 as Affiant thinks in the County of Halifax County North Carolina that she died as his widow on the __ day of __ 1838 leaving the following children viz. Affiant & Elisha Pilant a son by a former marriage that Affiant makes this declaration to obtain the Pension due to her under act 4th of July 1836 entitled an Act to obtain the benefit of the 3rd section of the Act of Congress of the 4th of July 1836 that there is no family record of the marriage within the knowledge of this Affiant.

State of Tennessee Robertson County: This day came Elisha Pilant before me a sitting Justice of the Peace in & for the State & County aforesaid who being sworn duly states that he knows that William Scott Father of the within named Petitioner William Scott was a Soldier in the Revolution War & during the whole of the same in the Virginia Line that he was lawfully married to Hannah his wife in the year 1780 as Affiant thinks that said Hannah Scott died as the widow of said William Scott in 1838 in Edgecombe County North Carolina and that William Scott the Affiant & this Affiant are the only living children of said Hannah Scott, Sworn to before me this 28th day of January 1850

Hannah Pilant and that he was present and saw them married – John Pilant at that time lived in Edgecombe County State of North Carolina – that he lived in the family of John Pilant eighteen years –
