Pension application of Henry Sharwood [Sherwood] R9501 Fernales f44VA Transcribed by Will Graves 2/3/12

Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." On this 20th day of December 1848 personally appeared before me Richard H Baker, Judge of the Circuit Superior Court of Law and Chancery for the said city of Norfolk, Fernales Sharwood a resident of the said City, aged eighty-nine years, who being first duly sworn according to law doth make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed on the 7th of July 1838, entitled an act granting half pay and pensions to certain widows; that she is the widow of Henry Sharwood, who was a private soldier in Captain Matthews' Company of militia, regularly organized in the time of the Revolutionary War; and that she has heard and believes, that he did serve as much as three years at different times; and she knows of her own knowledge that he did serve as a soldier in the Revolutionary War; that she does not recollect the name of any other captains, except Captain Matthews; that she has heard her husband, Henry Sharwood frequently say, that he served with Captain Matthews, also her four brothers say this same, and of his being at the battle at the Great Bridge [December 9, 1775]. She further declares that she was married to the said Henry Sharwood on the first day of October in the year 1791 and that her husband, the said Henry Sharwood, died on the 24th day of December 1801; that she was not married to him prior to his leaving the service, but the marriage took place previous to the 1st day of January 1794, viz., at the time above stated. She further swears that she is now the widow of said Henry Sharwood, and that she has never before made any application for a pension.

At a Quarterly Session Court held for Princess Anne County the 6th day of November 1848. The Court doth certify that satisfactory evidence has been produced to prove, by the oath of Jonathan Frizzell who being present in court, that Henry Sharwood the husband of Fernales Sharwood was a private Soldier in the militia service in the time of the revolutionary war, and served 3 years and that the said Henry Sharwood died in the year of our Lord 1801.
