Pension application of Francis Sampson (Samson) R9597 f12VA Transcribed by Will Graves 1/8/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Tennessee Smith County: On this 2 day of September 1832 personally appeared before me Exum Whitley one of the acting Justices of the Court of Pleas and Quarter Sessions for the County aforesaid Francis Sampson a resident of said County, aged about 87 [could be 85¹] years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed the 7th of June 1832. That he entered the service of the United States under the following officers, and served as herein after stated.

In the year 1777 or thereabouts, he enlisted for the term of 18 months in the County of Charlotte and State of Virginia he was attached to the Company of Captain Reuben Barksdale in the Regiment commanded by Colonel Thomas Read he served in said Regiment for the term of three months when he hired a substitute in his stead, for which he paid the sum of \$300. The name of his substitute, not recollected.

Afterwards he volunteered in the same State and County for the tour of 3 months, joined the Company of Captain John Clayton in the Regiment commanded by Colonel not recollected and in the Brigade commanded by General Lawson. He served about seven weeks, when he was discharged: but has lost his discharge. He never received one cent of wages in either case for his services. He has no documentary evidence and knows of no person whose testimony he can procure, who can testify to his service. He hereby relinquishes any claim whatever to a pension or annuity except the present, and declares that his name is not on the pension Roll of the Agency of any State or territory of the United States.

Ans. I was born November 27 day 1747

Question 2nd Have you any record of your age, if so where is it?

Ans. None

Question 3. Where were you living when called into service. Charlotte County where have you lived since the revolutionary war and where do you now live.

Ans. Some years in the state of Virginia Charlotte County and others in the same state until about 23 years ago I moved to Tennessee Smith County where I have resided ever since and now reside
