Pension application of William Skinner R9637 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 1786." Please call errors or omissions to my attention.]

State of Virginia & County of Fairfax: SS

On this 22nd day of August 1838 personally appeared before the County Court William Skinner a resident of the County and State aforesaid aged 78 years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832 – that he was drafted as a common soldier and served a six months tour of duty in the Virginia Militia in the year 1781 – and was marched from Alexandria under command of Major Dennis Ramsay Captain Robert Sanford and Lieutenant Thompson Mason Ensign not recollected [in] the spring 1781 and joined a large number of militia at Williamsburg commanded by General Weeden [George Weedon], and afterwards by the Marquis de Lafayette, from there the Army returned to the City of Richmond where we had a number of encounters with the British, sometimes in front & sometimes in Rear; finally day appeared South of James River and burnt the Manchester warehouses [April 30, 1781]; after which he was discharged, having completed and finished his tour of duty.

He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares that his name is not on the pension roll of the agency of any state. Sworn to and subscribed the day and year aforesaid.

State of Virginia Fairfax County: to wit

I Robert Radcliffe a Justice of the Peace in and for the County aforesaid do hereby certify that Henry S. Halley¹ of said County appeared before me this day and made oath that he is well acquainted with William Skinner of said County that he well recollects his serving a tour of duty as a soldier in the Revolutionary war in the year 1781 under the command of Major Dennis Ramsay. That he the said Henry S. Halley served with him in the same Battalion, & that as well as he recollects the company officers were Captain Robert Sandford and Lieutenant Thompson Mason (Ensign not recollected). He further states that Presley Gray² of Kentucky served in the same Company with the affiant and in the same Battalion with the said William Skinner. The term for which the said William Skinner was drafted this affiant has no recollection of but well

recollects his marching from home in the year 1781 and returning sometime in the summer following and that the said William Skinner discharge faithfully the duties of a soldier during the whole time he was in service, and was honorably discharged.
