Pension application of Joseph Sloan R9663 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 0.786." Please call errors or omissions to my attention.]

Herewith are transmitted for the action of your department the application of Joseph Sloan for a pension under the act of Congress passed June 7th, 1832.

The age of this applicant being much advanced it is not to be expected his recollection of names could [be] very distinct. He cannot recollect by which authority his Company, that he has Captain McMahens [?] Company was called into the Service, and hence it is not stated in the declaration, but enough is remembered, I think, upon a reference to the rolls of the Virginia Militia to corroborate his statement.

His age and circumstances forbade his getting the testimony of John Morrison and Elijah Hedge the two persons referred to in the declaration as knowing to his having rendered the services for which he claims a pension.

You will please communicate to me the action of the department in his case.

¹ MILLER, John Krepps, a Representative from Ohio; born in Mount Vernon, Knox County, Ohio, May 25, 1819; attended the public schools; was graduated from Jefferson College, Canonsburg, Pa., in 1838; studied law; was admitted to the bar in 1841 and commenced practice in Mount Vernon, Ohio; delegate to the Democratic National Convention in 1844; elected as a Democrat to the Thirtieth and Thirty-first Congresses (March 4, 1847-March 3, 1851); died in Mount Vernon, Ohio, on August 11, 1863; interment in Mound View Cemetery. http://bioguide.congress.gov/scripts/biodisplay.pl?index=M000742
