Pension Application of Isaac Stackhouse S11473

State of Ohio Monroe County Ss

on this 21st day of Sept AD 1832 personally appeared in open Court before the Court of Common Pleas for said County now Sitting Isaac Stackhouse a Resident of Franklin in the County of Monroe and State aforesaid aged 81 years who being first duly Sworn according to Law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832 that he entered the Service of the United States under the following named officers and served as herein stated that he entered the service in the Spring of 1781 and served a six months tower in a Company of which Jacob Fisher was Lieutenant. Capt and Ensign not Recollected Served under the immediate Command of General Washington and served the principal part of the time at Little york [Yorktown] in virginia was Discharged in Frederick County Virginia – that he Lived in virginia when caled into service that he was Drafted – that all the Battle he was in was the takeing of Lord Carnwallice [sic: Cornwallis, 19 Oct 1781] that previous thereto he volunteered for three months in the year 1776 under Capt James Booth & Lieutenant Nathaniel Davison and Stationed at Thomas Nutters fort [on east bank of Elk Creek now in Clarksburg WV] to guard the frontiers in monongahala [sic: Monongalia] County Virginia in which County he volunteered and served —

and that previous thereto he volunteered and served six months under Zachariah Morgan in the year 1774 at Lewis Rodgerses [Fort Morgan] near Morgantown in virginia and served the said six months at said fort Said Morgan was Captain and John Hurd Ensign Lieutenant not Recollected was stationed to guard the frontiers

1st where and in what year were you Born

Ans - I was Born in Hampshire County Virginia in the year 1751 -

2nd have you any Record of your age

ans - none that he remembers his age from his fathers record

3rd where were you Living when caled into service where have you lived since the Revolutionary War and where do you no live

I lived on Cheat River when first caled in to service and next lived in Harrison County Va and last time in Moorefield Virginia Since the war I have lived Harrison County Virginia since in ohio 4th how were you caled into service were you drafted did you volunteer or was you a substitute and if a substitute for whom

ans I was Drafted onc for six months I volunteered for three months and also for six months $5^{\rm th}$ State the names of some of the Regular officers who were with the troops where you served such Continental and Militia Regaments you can recollect and the general circumstances of your services

I was stationed on the frontiers under Booth and [illegible word] Morgan against the Indians and suffered the hardships of the frontiers Lastly at the taking of Cornwallice

6th did you ever receive a Discharge from the services and if so by whom was it given and what has become of it

ans I received Discharges but they were Burnt in my house together with the house.

7th State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for varacity and their belief of your services as a soldier of the Revolution
