## Pension application of Thomas Walston S11661 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Camden County}

On this 13<sup>th</sup> day of November 1833 personally appeared in open Court before George Furber, Joseph Cartwright, Benjamin D. Harrison & Mal. W. Boushall Justices of the Court of Pleas & Quarter Sessions for this County of Camden & State of North Carolina now sitting Thomas Walston a resident of said County & state aged seventy-one or there about who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7<sup>th</sup>, 1830 2 – He says that he first entered the service according to the best of his recollection in January 1782 & served at North West in the State of Virginia under General Isaac Gregory of Camden on this tour he served three months and was then discharged but has lost his discharge. He is not certain but thinks his Captain's name [p 6] was John Jones – a man by the name of Jasper Pickett was an Ensign in the Company to which he belonged – he remembers a man by the name of Salyer who had some command but cannot tell what office he held. He can prove by Jesse Perry <sup>1</sup> that was with him during this time he served at North West but he knows of no other person by whom he can prove his service and he has no documentary evidence by which he can prove it.

In the Spring of the year 1782 he enlisted into the service for one year and marched to Hillsboro in the State of North Carolina under the command of a Frenchman by the name of Peter Pouchee [Peter Pouchet], and that said Pouchee was afterwards in Adjutant and finally ran away from the service. He remained at Hillsboro nearly the whole of the year for which he enlisted and was under the command of Major Thoroughgood & Major Crafton [Bennett Crafton], during this year he was once marched to Briar Creek under the command of his officers but remained but a little time and then returned. He knows of no person by whom he can prove this tour of service, but he avers that he served one whole year on the above enlistment and he [p 3] can prove by Isaac Harrison he enlisted into the service & left this part of the County and as he supposed went into the service. He hereby appends all the Documentary evidence he has, the one purporting to be a certificate of service signed A. B. Col. Camden Regiment & dated on the 7<sup>th</sup> April 1791 – he cannot now remember why he took this certificate & can only say he found it among his old papers. The other documentary evidence hereto appended he believes to be a certificate given him at the time he enlisted by the officer under whom he enlisted, but as the paper is partly destroyed & as he is not aided by his memory in the matter he cannot say with any greater certainty what this paper is. He thinks he had a discharge when he left the Army but if he had he has lost it & cannot now find it.

He hereby relinquishes all & every claim whatever to a pension or annuity except the

present and declares that his name is not on the pension roll of the Agency of any State.



This Affiant further says that he was born in the year 1754 and that he recollects that it was said during the revolutionary war that Thomas Walston the applicant was gone into the service and he knows he was absent for a considerable length of time from the County and when he returned it was said & believed that he had been in the Service and that he has no doubt that such was the fact.

Sworn before me in open court this  $15^{\text{th}}$  of November 1833.


This may Certify that Thomas Walston a Soldier in the State Legion his time of service is out on the  $15^{th}$  day of March in the year of 1783.
