Pension application of Charles Wickcliffe S1271

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 0.786." Please call errors or omissions to my attention.]

State of Kentucky City of Lexington Sct.

On this third day of May 1833 personally appeared before me the Mayor of said City Charles Wickcliffe a resident of said city aged 67 years who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed 7th of June 1832.

That he entered the service of the United States under the following named officers & served as herein stated:

He first turned out in the militia of Prince William County Virginia under Captain Peter Evans & the Regiment was commanded by Colonel James Garrard of Stafford County Virginia at the age of 15 or 16 years, he thinks in 1780 in the summer & served between three & four months – we marched through Stafford County to Hunters Height on the Rappahannock [River] above Falmouth & marched back to Dumfries & were dismissed – we were in no action – There were no Regular officers with him & he served as a private on foot.

The 2nd tour, the following year, he served in the militia from Fauquier – in a troop of volunteer Light horse under Captain William Triplett – attached to a Regiment of Militia in Gloucester, whither we marched – we were, while in Gloucester, routed by Colonel Tarleton [Banastre Tarleton] light horse & many of our horses taken & afterwards we were discharged – this tour was a short time over three months & we always stood ready when called on to march again – we bore our own expenses & received nothing but our rations – as compensation –

He has no written or documentary evidence in his possession showing his services & knows of no one by whom he can prove the same, now living & whose testimony he can procure. He has no record of his age, but states his age as reported to him by his parents. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the Agency of any State.

Sworn & subscribed the day & year aforesaid. He is known to many of his fellow citizens & refers to Major William Barry the postmaster General. He names also the honorable Henry Clay, the Honorable children Allen – Robert Wickcliffe Esquire, Richard Ashton, Captain John Lowry, General Thomas Bodley – as persons who will testify to his character & standing
