Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Dear Sir

Your favor of the 29th of March last Came to hand but being Engaged in business that Required my whole attention I have not seen Mr. Edward Griffin until in November when I called on him in the State of Georgia but not having your letter with me I forgot the order but I herewith send you Mr. Griffin's memorial Directed to the Honorable the Secretary of war and Certified by a Notary Public which I hope will enable you to get him placed on the pension list of the United States, which I also hope will prove a timely Relief to the Distressed I assure you Sir when I entered Mr. Griffin's house it was with astonishment and heartfelt grief that I beheld the Distress of the family. Mr. Griffin is as I informed you a very poor man but to add to his other misfortunes his wife Mrs. g. has long been afflicted with pains which has terminated in the white Swelling and She has become Ulcerated in almost all over, and is Entirely helpless and She together with her poor little Ragged Children Exhibits a picture truly melancholy. I hope therefore you will pay attention to this business as soon as your own most weighty Concerns will admit, and I shall pay Every attention hereafter to your further Instruction when you get him placed on the pension list be kind Enough to take the Certificate out of the office and send it to me Directed to Barnwell Post Office and I will take it to Mr. Griffin Immediately as I know he is in great Distress.

¹ CHAPPELL, John Joel, a Representative from South Carolina; born on Little River, near Columbia, Fairfield District, S.C., where the family was on a visit, January 19, 1782; as an infant was taken by his parents to their home on the Congaree River, Richland District, S.C.; attended the common schools and was graduated from the law department of South Carolina College (now the University of South Carolina) at Columbia; was admitted to the bar in 1805 and commenced practice in Columbia, Richland County, S.C.; appointed adjutant of the Thirty-third South Carolina Regiment in 1805 and elected captain and then colonel of the same regiment in 1808; member of the State house of representatives 1808-1812; appointed trustee of South Carolina College in 1809; served in the War of 1812; elected as a Republican to the Thirteenth and Fourteenth Congresses (March 4, 1813-March 3, 1817); chairman, Committee on Pensions and Revolutionary Claims (Thirteenth and Fourteenth Congresses); resumed the practice of law until 1837; director of the Columbia branch of the State Bank of South Carolina 1830-1858; moved to Lowndes County, Ala., and became a cotton planter; died in Lowndes County, Ala., May 23, 1871; interment in First Baptist Church Cemetery, Columbia, S.C. http://bioguide.congress.gov/scripts/biodisplay.pl?index=C000320
