Pension application of Samuel Rouse S14360 Transcribed by Will Graves f10VA 8/6/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky County of Boone:

On this 9th day of October in the year 1832 personally appeared before me Robert Walton a Justice of the peace in and for said County of Boone Samuel Rouse a resident of said County of Boone & State of Kentucky aged between seventy-nine & eighty years who is unable by Bodily infirmity to attend Court, and who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named Officers & served as herein stated – That he entered the service of the United States in the year 1777 under Captain Ephraim Rucker as a private, he was drafted to serve a tour of two months which was then in Culpeper County Virginia where he then lived – He served said tower [tour] of two months under said Rucker in which time he marched with Rucker to the state of Maryland under Colonel James Barbour & was stationed a part of the time not far from Fredericktown Maryland & at the end of the tower he returned home without being in any particular engagement – in a year or two after that time, he was again drafted to serve a tour of two months under Captain Jos. Wood from Culpeper down to Falmouth in Virginia & there guarded that place which was then under Greene & continued there until discharged from the tower by General Greene & returned home again – After which a year or two that he is in the year 1781 he was again drafted as a militia man he served a tour of two months under Captain Triplett or Lieutenant Hanes who was the acting officer as Captain Triplett was sick in which time he marched from Culpeper to York & there served with the Militia & Regular troops under General Washington & others & were engaged in taking corn Wallace [October 19, 1781] after which capture he returned home – that he has no documentary testimony or evidence by which he can establish his services. That he has no other evidence except that which is hereto annexed.

He hereby relinquishes every claim whatever to a pension or annuity except the present & declares that his name is not on the Pension Roll of the agency of any State.

I Robert Walton a Justice of the peace in & for said County of Boone do hereby certify

that Jacob Rouse¹ a resident of said County of Boone who is about 74 years of age & duly sworn deposeth & saith that he lived in Culpeper County Virginia during the time of the revolutionary war & was acquainted with Samuel Rouse who is now present & an applicant for a pension & recollects that said Sam Rouse was as he states drafted at three different times to serve three different tours of two months each & that he served them as he states the 1st under Captain E. Rucker, the 2nd under Captain Jos Wood [Joseph Wood] & the 3rd under Captain Triplett or Lieutenant Hanes.

[Veteran was pensioned at the rate of \$20 per annum commencing March 4th, 1831, for service as a private for 6 months in the Virginia militia.]
