Pension application of William Taylor S14647 Transcribed by Will Graves

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky Rockcastle County Sct.

On this 26 day of November 1832 personally appeared in open Court, before the Justices of the Court of Rockcastle now sitting William Taylor a resident of Rockcastle County & State of Kentucky aged 74, this fall who being first duly sworn according to law, doth on his oath make the following declaration, in order to obtain the benefit of the Act of Congress, passed June seventh, 1832.

That he entered the service of the United States as follows to wit; First in 1777 in Rockbridge County State of Virginia where he resided, in the month of October he entered the service of the United States as a militia Private in the line of the State of Virginia for three months in the Company commanded by Captain Gray [probably David Gray] in the Regiment commanded by Colonel John Bowyer, his Lieutenant was Paxton [perhaps John Paxton], Ensign forgotten. He does not remember his Major. In this engagement he was [in] no regular Battles but only some scrimmages. He marched in Virginia from Petersburg to Suffolk, then James Town thence to Richmond Virginia where he was discharged (1778) by his Captain aforesaid (Grav) after having served out his term [of] three months] which he has long since lost. He does not remember any regular officers on said trip except General Muhlenberg under whose orders his Regiment served. Next he in the year 1781 he was drafted in Rockbridge County, State of Virginia in the [company] Commanded by Captain Elliott [probably James Elliott] in the line of the State of Virginia in the Regiment commanded by Colonel Fleming [perhaps William Fleming] or Morphit [? PERHAPS, George Moffett], which he does not remember, but Morphit lived in Augusta Virginia & Fleming in Botetourt same state. When he entered the service he was marched from Rockbridge to Williamsburg and in that section & to the siege of York and remained there until Lord Cornwallis was taken. And after serving out his term of service for three months as aforesaid he was discharged by Captain Elliott as aforesaid at Williamsburg, which he has long since lost. On the last trip he remembers regular officers General Washington, General Lincoln & many others whose names he has forgotten. He has no documentary evidence that he knows of or person whose testimony he can procure who can testify to his service. He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares that his name is not on the pension Roll of the Agency of any State, nor has it ever been.

That he was born in Virginia Augusta County, he has no record of his age. He lived in Rockbridge County Virginia when he entered the service as stated by him as aforesaid and since the Revolution War he lived in Rockbridge County then in Augusta Virginia & back to Rockbridge County & [indecipherable words] to Kentucky where he has lived in Rockcastle County for 22 years. As to the manner of entering the service he has explained but this I [indecipherable word] was upon his own account. To the 5th question he has explained. As to his discharges, he has explained. He received no Commissions, but was a private. As to his character for veracity and his service in the Army he refers to the Reverend John Quin, General William Smith & Thomas Jones.
