Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Virginia Halifax County to wit

On this 22nd day of November 1832 Personally made oath before me John S Vaughan a Justice of the peace for the County aforesaid Archibald Warren a resident of the County & State aforesaid aged seventy-six years, who is not able to attend court owing to his old age & bodily infirmity being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by an act of Congress passed 7th of June 1832, this applicant states that he entered the service a militia man under the command of Captain Peter Rogers marched from Halifax County & state aforesaid crossing Dan River at Boyd's ferry at a place now called South Boston & from there crossing Stanton River at Bonds or Bibs Ferry, and from thence to Petersburg & from thence below Petersburg, and was there discharged after serving a tour of three months. That a second time he was drafted and served under Colonel George Bogg and Captain James Coleman & Lieutenant John Rogers, and served nearly in the same direction as the first and was discharged for that tour of duty below Petersburg. That he served a third tour under Captain George Wiley crossing the above mentioned River marching below Petersburg and served that tour round about that place. That he served a fourth tour under Captain George Moore and went on under Colonel Wm Moore [William Moore] crossing Haw River at hyghrock Foard [High Rock Ford], came near Hylsborough [Hillsboro] and from thence joined General Green's [Nathanael Greene's] Army and was at the Battle of Guilford, after which he served two months making in the whole eleven months of his service in the revolutionary war. That he was a resident of Halifax County Virginia in the time of the revolutionary war, have lived ever since the revolutionary war in the same except about two years he lived in the State of Georgia, that his discharge was destroyed and he cannot find them, that he has no record of his age that he knows but one person by whom he can prove his service that is now living [ink blot covers the word] Lewis Parrott. He hereby relinquishes every claim whatever to a pension or annuity except the present & that his name is not on the pension Roll of the agency of any State.

Warren a resident of the County & State aforesaid and that he has knowledge of his services as a Soldier in the revolutionary war, but does not recollect so well where he was in service but believes to the best of his recollection he was under General Gates.

[Veteran was pensioned at the rate of \$36.66 per annum commencing March 4th, 1831, for 11 months service as a private in the Virginia militia.]
