I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 1786." State of Indiana County of Jefferson: SS

On this 13th day of August 1832 personally appeared before the Probate Court of the County and State aforesaid Charles Steward a resident of the County of Ripley in State of Indiana aged 73 years, who being first duly sworn according to law, doth on his oath, make the following declaration, in order to obtain the benefit of the provision may by the act of Congress passed June 7th 1832. That he enlisted in the Army of the United States in the year 1775 with Lieutenant Stubblefield and served in the 1st Regiment, he thinks, of the Virginia line under the following named officers Lieutenant Stubblefield, Captain Gabriel Jones, and Colonel Gibson. He lived in Spotsylvania County Virginia when he entered the service – went from thence through Fredericksburg down to Hobbs hole where he was stationed a considerable time went thence into the marine service in the neighboring capes & bays was in service under this enlistment about 18 months – out of the marine [service] he enlisted into the land service for three years with Lieutenant Stubblefield on the 20th day of December 1776 and served under the same officers, to wit, Lieutenant Stubblefield, Captain G. Jones and Colonel Gibson of the aforesaid Regiment and line – marched up through Hobbs hole to Fredericksburg from thence to Alexandria with the whole Army was inoculated for the small pox – from thence to Georgetown Maryland where he was taken sick and received a furlough to return home and recover his health, not long after recovering his health he joined a company at Fredericksburg, that was going to join the main Army, but was taken sick again and received a furlough to return home. Applicant did not join the Army again. He hereby relinquishes every claim whatever to a pension or an annuity except the present, and he declares that his name is not on the pension roll of any agency in any State -
