[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Indiana Knox County SS

On this 7th day of September 1832, personally appeared in open Court, before the Honorable Amory Kinney President Judge of the Circuit Court of said County now sitting, Jaret Young, an inhabitant of this County, who being first duly sworn according to law, doth, on his oath; declare that he was born in Virginia, raised in Camden district now Chester County, South Carolina, and that his age, agreeable to the family report, is about 70 years, being born sometime in 1762; that he was drafted in Camden district, and joined a company of John McCool in Col. Hampton's Regiment; that they were attached to the troops under General Green [sic, Nathanael Greene]; that they attacked the Congaree Fort, and after some fighting, the garrison surrendered; ¹ that some of the troops, amongst whom he was, were detailed and marched, under General Sumpter [sic, Thomas Sumter], to near Charleston, from thence to Thomson's Fort, from there to the four holes, from which place they retreated and again joined the Army under General Greene at Fort Congaree, where the Regiment was discharged; That in 1780, or '81, he was again drafted in said district, and County, of South Carolina, and joined a Company under Capt. Amos Davis in a Regiment commanded by Col. Lacy [sic, Edward Lacey]; that they marched to Orangeburg, from thence to the South fork of Edisto [River], where they were encamped on Youngblood's farm, for some months; that from thence they were ordered to Orangeburg and discharged; that his entire service in the two campaigns, occupied more than six months time; that the different regiments were drawn up in line and dismissed, and that no written discharge was given; That after this, he joined a volunteer horse company under Capt. McCool and scouted in different directions through the country, at various times, in pursuit of the Tories; That he resided in Chester County until he removed to Kentucky, and in the year where he resided some time in Posey County, from thence he moved to Knox County, where he has ever since resided: that he has no documentary evidence, and knows of no person but James C. Veale, whose testimony he can procure, with a personal knowledge of the Services related. He hereby relinquishes every claim whatever to a pension or annuity except the present, & declares that his name is not on the pension roll of the agency of any State.

We, James C. Vaele [sic], residing in the County of Daviess, Indiana, and Daniel Hollingsworth residing in Knox County, said State, do hereby certify and declare, that we had each of us, have been acquainted with Jaret Young, who has subscribed and sworn to the foregoing declaration, since we were boys, of adjoining neighborhoods, in the State of South Carolina; that we believe him to be 70 years of age, or thereabout; and James Vaele further certifies and declares, that he knows said Jaret Young served as an American soldier in the Militia of South Carolina, in the revolutionary war; and he remembers seeing said Young in the service, at Congaree Fort: and said Vaele and Hollingsworth, unite in declaring that the said applicant, Jaret Young, has always been reputed, and believed, to have been a soldier of the revolution and concur in that belief. Sworn to and subscribed in open court, the day and year aforesaid.

[Facts in file: the veteran died January 10, 1835 in Knox County Indiana at the home of his son-in-law, Peter Hollingsworth, leaving 4 children in said County and two other children who had not been heard from for 5 or 6 years prior to his death. None of the children are named in the material in the file.]

[Veteran was pensioned at the rate of \$20 per annum commencing March 4th, 1831, for service as a private for 6 months in the South Carolina militia.]
