## **Southern Campaign American Revolution Pension Statements & Rosters**

Pension application of Elisha Yeager S16587 Transcribed by Will Graves fn25VA 7/14/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

## State of Kentucky Jefferson County: to wit

On this twenty third day of August in the year 1832 Personally appeared before the undersigned one of the Justices of the Peace in & for the County of Jefferson & State aforesaid Elisha Yager [sic] a resident of said County aged nearly seventy-one years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. That he was born on the 30th day of November 1761 in the County of Culpepper [Culpeper County] & State of Virginia where he resided until he entered the service of the United States as a militia soldier in the war of the Revolution in the year 1777. That he first served in a company commanded by Captain Fisher Rice, in a Regiment commanded by Colonel Francis Taylor that he marched with his Company to Albemarle Barracks in Virginia & was there sixty days assisting in guarding the Prisoners taken at the surrender of General Burgoyne. He further states that after his discharge he again entered the service in the County of Culpepper in Virginia under the Command of Reuben Beall as well as he now recollects in the year 1778 or 1779 & that he was marched with a detachment sent to guard the Rappahannock & Appomattox Rivers from the British fleet & that he served for the Term of 60 days & was discharged at the Expiration of his Term of Service & was discharged in the County of Spotsylvania Virginia. That he again entered the service in the County of Louisa & State of Virginia under the Command of Captain Elijah Kirtley in a Regiment commanded by Colonel Jack Willis [John Willis?] in the division or Brigade commanded by General Muhlenburgh [Peter Muhlenberg], that after serving some time under Colonel Willis he was with his Company detached & acted as a riflemen & was in the Engagement at Hot water Creek in the County of New Kent, Virginia in the latter end of June 1781, from which place the British marched to Jamestown & from thence to Norfolk & that the detachment to which he belonged was in pursuit of the British when they entered Jamestown which day the British, burnt. He states that the whole period of time that he was in the service of the United States as a militia soldier from the time he first entered until he quit the service was six months, & that he knows of but one person by whom he can prove any part of his service whose affidavit accompanies this declaration – And he further states that he had his several discharges but that from lapse of time, & his frequently moving & changing his residence the same have been lost or destroyed. He hereby relinquishes every claim whatever to a Pension or annuity except the present & declares that his name is not on the Pension Roll of the agency of any state or Territory

Commonwealth of Kentucky Oldham County: Sct.

This day Personally appeared before the undersigned one of the Commonwealth's Justices of the peace in & for the County of Oldham Samuel Yager<sup>1</sup> who being duly sworn state that he is the relation of Elisha Yager of Jefferson County Kentucky that he knew said Elisha in State of Virginia & that he the said Elisha was upon three Tours of Duty as a Militia Soldier as he believes & that he served sixty days each tour & further states that he served himself with the said Elisha upon one of those Tours under the Command of Captain Elijah Kirtly in a brigade or division Commanded by General Muhlenberg.
