Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Declaration in order to obtain the benefit of the act of Congress of the seventh of June 1832 On this 11th day of June A.D. 1833 personally appeared in open Court before the County Court in and for the County of Ralls Samuel Turner a resident of said County of Ralls and State of Missouri aged 75 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by act of Congress passed June seventh 1832. That he entered the service of the United States as a Militia man of the Virginia line or troops and served in the Revolutionary War in the year 1781 under the following officers herein after named

Question – Where and in what year were you born

Answer I was born in A.D. 1758 Culpeper Virginia

Question by same have you any record of your age & if so where is it

Answer I have had one but it was burned in my grandfather's

Question by same Where were you living when called into service

Answer Culpeper County State of Virginia

Ouestion where have you lived since the Revolutionary War and where do you now live

Answer part of my time in Clark County Kentucky and balance in Ralls County Missouri where I now live

Question how were you called into service

Answer I was drafted and no Captain Gabriel Jones was a Regular and killed at the battle George [indecipherable end of word or new word] was a regular soldier but his term was out during the time I was in the service

Question by court did you ever receive a discharge & if so by whom was it signed and what has become of it

Answer I did but have lost it, it was given to me but by whom I can't recollect

State the names of persons to whom you are known in your present neighborhood who can testify as to your character for veracity

Answer Colonel William Grey & Jeremiah Vardiman

[Jeremiah Vardiman, a clergyman, and William Grey gave the standard supporting affidavit.]

[Facts in file: the veteran died April 17, 1847 leaving children whose names are not stated in the file. The file contains no discernible family data.]

[Veteran was pensioned at the rate of \$20 per annum commencing March 4th, 1831, for service as a private for six months in the Virginia militia.]
