Pension application of William Smithers S17682 Transcribed by Will Graves

Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 0.786." Please call errors or omissions to my attention.]

State of Indiana Dearborn County: SS

On this 4th day of October 1832 personally appeared in open Court before the Judges of the Dearborn Circuit Court now sitting William Smithers a resident of Lawrenceburgh Township and Dearborn and State of Indiana aged ninety-one years the 22nd day of December next who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832. That he was born in the County of Stafford Virginia the 22nd of December 1741 he has a family Record that he was born on the day and at the place aforesaid.

That he was drafted on the first tour of Virginia militia time not recollected served 2 months in Captain Legs [sic, perhaps Capt. John Legg's of Spotsylvania County?] Company marched to Richmond stayed about one week then to Cabin Point then to Portsmouth was discharged at Petersburg we were commanded by Colonel George Stubblefield.

That he was drafted a second time under the same Captain Colonel McWilliams [perhaps Lt. Colonel William McWilliams of Spotsylvania County?] Marched to _____ thence ordered to march through Culpepper [County] to meet the British and was discharged having served two months.

He was afterwards drafted under the same Captain Colonel Shew or Chew, went to guard the prisoners from York to Winchester and was there discharged having served two months making in all six months, that perhaps his name be enrolled on the Virginia Rolls that is if any were kept of the drafted men. I was living at Stafford County Virginia when drafted & lived there after the War for some time then removed to Franklin County Kentucky where I resided about 22 years then to Indiana where I have resided the last 18 years. I have no documentary evidence nor discharges if ever any high know of no person now living who can testify to my service. I am old, poor and unable to send or examine therefore I hereby relinquish every claim whatever to a pension or annuity except the present and declare that his name is not on the pension Roll of any agency of any State.
