Pension application of Ambrose Hudgens (Hudgins) S18888 f22SC

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

South Carolina, Laurens District

The humble petition of Capt. Ambrose Hudgens shews unto the Honorable the members of the Senate & House of Representatives of the State of South Carolina, That he was a soldier of the Revolutionary War and performed many tours of duty (to wit) One under Col. William Thompson [sic, William Thomson] for six months within this State & Georgia; one other under Col. Williams [James Williams] for many months; one other of three months under Col. Purvis and your petitioner on oath saith he was a faithful soldier and is now about sixty eight years of age, old & infirm and his wife is about the same age and of a good Whig family and from their advanced age infirmity & poverty your petitioner feels full confidence in the Justice & magnanimity of the Legislature of this State toward al old war worn soldiers who served many tours of duty than aforementioned but now unable to prove them. Your petitioner is now worth about 150 acres of Land very poor and much worn out but does for a home for himself & aged companion, 10 head cattle & 1 head hogs and one horse worth fifty Dollars one bed & furniture of little value and your petitioner in duty bound will ever pray.

South Carolina Laurens District: Personally came James Dillard¹ before me John Whitmore one of the Justices assigned to keep the peace in said District and made oath in due form of law and on his oath saith Ambrose Hudgens was a listed soldier in the State troops of South Carolina under Capt. Brown and Col. William Thomson's Regiment and this deponent believes that he served his time fully out and got a legal discharge with myself from said Regiment and that I frequently saw him bearing arms in the said State to the end of the war and further saith not. State of South Carolina Anderson District: Personally came and appeared before me the subscribing Justice William Millwee² Esquire who after being sworn in due form of law deposeth on his oath that Ambrose Hudgens now residing in Laurens District in the State aforesaid was a faithful soldier under said deponent's command who was Capt. in Col. Williams' Regiment of South Carolina in defending the State of Georgia in the Indian War that deponent further deposeth that he did deceive the said Ambrose Hudgens enlisted himself as a regular soldier in the United States service under Lieut. Robert Long in Col. William Thompson's Regiment in the Revolutionary war this Deponent also deposeth that he has every reason to believe and does believe that he the said Ambrose Hudgens did faithfully served his full Tour of Duty which was for the term of 6 months and was discharged with credit. State of South Carolina Laurens district: On this 4th day of December in the year of our Lord 1849 personally appeared in open Court before the Court of Ordinary now sitting Col. John Hudgens a resident of the District of Laurens in the State of South Carolina aged 46 years who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the benefit of the Act of Congress passed June 7 1832. That he is the son and heir at law and administrator of the Estate of Ambrose Hudgens, deceased who entered the service of the United States under the following named officers and served as herein stated: That he entered the said service in the Company commanded by Capt. Brown Lieut. Robert Long in the 3rd South Carolina Continental Regiment commanded by Col. William Thomson and in the capacity of a private served In That Regiment 6 Months: afterwards said Ambrose Hudgens deceased served under Col. Purvis and many months under Col. Williams [James Williams] of the militia Service & in the Company commanded by Capt. William Milwee: That whilst under said Capt. W. Milwee he the said Ambrose Hudgens was in Georgia in what was called the Indian Wars: That as to the battles in which he was engaged this Declarant remembers only that of Eutaw Springs in South Carolina as stated by his Father in his lifetime; but the counties through which he passed this Declarant does not now recollect: That before and since the Revolutionary war said Ambrose Hudgens deceased lived in Laurens District in South Carolina and in the year 1829 was pensioned by the legislature of South Carolina and died 30th day of January in the year 1844 never having applied for a pension from the United States: That he said Ambrose Hudgens left

no widow, his wife having died in 1833. He hereby relinquishes every claim whatever to a pension or an annuity except the present and declares that his said father's name is not on the Pension Roll of any agency of any State except as above set forth.

The veteran was granted a pension by the SC Legislature commencing in June 1830 at the rate of \$60 per annum. There is a voucher showing payment of \$120 dollars as annuities due Ambrose Hudgens and Joseph Rogers as of June 6th 1842.]
