Pension application of Jeremiah Taylor (Tayler) S21527 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina Fairfield District

On this second day of November in the year of our Lord 1832 personally appeared in open court before William D. Martin -- one of the Judges of the Court of Common Pleas and General Sessions now sitting in Fairfield Court House in the District in State aforesaid Jeremiah Taylor a resident of the District aforesaid, aged seventy years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed 7th of June 1832. That Deponent was born on the Virginia & North Carolina line and before the Revolutionary War followed his father to the District and State aforesaid and the District of Fairfield has been his home ever since. He will be 70 years of age the 25th of January next. ^{Has no record of his age and never knew of any. His mother told him his age and he has remembered it ever since. Deponent served as a private soldier in the militia during the Revolutionary war as follows and never received any written discharge at any time from the service. Deponent was}

follows and never received any written discharge at any time from the service. Deponent was first drafted ^{and always served in draft} for an expedition to Florida in a company commanded by Captain William Simmons and in a Regiment commanded by Colonel Robert Goodwyn [Robert Goodwin]. Colonel Winn commanded one Regiment. General Williamson [Andrew Williamson] was the commander of the whole.¹

Deponent does not know the object of this expedition. They marched to St. Mary's [River]. Deponent was out in this service about 4 months. This service was from May to September, but do not recollect the year certainly. Deponent, in the following winter as he believes under the same Captain Simmons & Colonel Goodwyn was marched to the bank of the Savannah [River] opposite Augusta. Deponent was there as a soldier 3 months, Augusta then in possession of the British & the object was to keep them from crossing the Savannah. General Williamson was the commander. General Lincoln [Benjamin Lincoln], a Continental officer arrived there about the time Deponent was discharged.

This Deponent was afterwards in a company under Captain Jas. Craig [James Craig] marched to the Congaree River at Ancrum's plantation a little below Fort Congaree. They remained there until a Fort [Fort Granby, May 14-15, 1781]² under Captain Maxwell surrendered. Thomas Taylor was Colonel. They were then marched to join General Greens [sic, Nathanael Greene's] Army on the Congaree near Haigs plantation the object being to attack Rawdon at Orangeburg. They were marched near Orangeburg & General Greene gave orders for all to march again to Biggin Church about 32 miles from Charleston. Colonel Wade Hampton

here took 13 prisoners from the British & the British burned the church & retreated to Charleston. After returning to Haigs, they were marched to Eutaw Springs [September 8, 1781].³ Deponent was drafted to take charge of 4 horses during the battle of Eutaw ^{this tour 4 months or more}. Deponent then returned home. Deponent after this was on duty three months in Orangeburg in the same company & again a three months tour at the four hole bridge 40 miles from Charleston.

Deponent was on duty at least 17 months, besides other scouts & short tours of duty of which he cannot give any particular account.

Deponent hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any state. Sworn to and subscribed the day and year aforesaid.

Deponent also knew the said Jeremiah Taylor in the camp opposite to Augusta and afterwards at the surrender of the Congaree Fort and he is certain he performed the duty as he has stated.

Deponent was with him in every Tour of duty which he has stated excepting the Battle of Eutaw and knows that he did perform all the duty which he has stated in his aforesaid Declaration that he had the reputation of being a good soldier & is a respectable citizen, And that he is reputed and believed in the neighborhood where he resides to have been a soldier of the revolution.

That deponent served with him in the tour to Augusta mentioned under General Williamson, next at the Eutaw battle, next at Orangeburg, next at the four hole Bridge, & that the statement given by him he is correct as to these tours. And deponent being his brother had an opportunity of knowing of his being out on other tours, And is satisfied that his Declaration is correct.
