Pension Application of James Hamilton S25128

Augusta County [VA], towit

This day James Hamilton came before me one of the Majistrates for the County afforesaid and made oath that he is the same James Hamilton to Whom the original Certificate in his possession was given, of which the following is a Copy

"I do with the advice of the Council of State, hereby certify that James Hamilton of Augusta, about 30 years of age, was a private in the militia of [several illegible words] appears to have been disabled in such a manner while in the service of the united States, as to entitle him to the sum of ten pounds yearly; which allowance is accordingly made him, to commence from the first day of January 1786

Given under my hand at Richmond this 13 day of Novem'r. 1786 P. Henry The above is a true copy of an original certificate granted to James Hamilton &c

Given under my hand as Governor of the commonwealth of Virginia at Richmond this 6 day of December 1799

James Wood"

That he was in the service of the united states when he was disabled at the Battle of Hot Water in the State of Virginia [26 Jun 1781] That he hath resided in the County of Augusta from his Birth.

Given under my hand this [blank] day of [blank] 1800

Know all men by these presents that I J. H. of the County of Augusta & state of Virg'a. do make constitute & appoint RG of the City of Richmond my true & lawful attorney – In my behalf to receive of the Comm'r. of loans[?] for the State of Virginia my Annual Pension as an Invalid of the united states, commencing the 4th Day of Septem 1799 & ending the 4th Day of September 1806 [one line illegible] acts requisite for effecting the premises. Hereby ratifying & confirming all that my said attorney shall Lega[page torn] do therein by Virtue hereof

The County of Augusta to wit

On this thirtieth Day of July 1823 before me the Subscriber a Justice of the peace for the said County of Augusta personally appeared James Hamilton who on his oath declares that he is the same person who formerly belonged to the Company Commanded by Captain Patrick Buchannan [Patrick Buchannan] in the Regiment Commanded by Colonel Thomas Hugart in the service of the United States during the Revolutionary war and that he was placed on the Pension List Roll of the Virginia Agency at the rate of \$4 43/100 11/15 Dollars per month, and that he has never received a Certificate from the war Department to that affect.

Sworn to and Subscribed before me this thirtieth Day of July 1823 Wm. Davis [A similar letter was written 29 Mar 1827.]

[The following are from pension records in the Library of Virginia.]

This is to Certifie that James Hamilton of Capt Pattrick Bucchanans Comp'y of Militia & Col Sampsons Mathews's [sic: Sampson Mathews's] Reg't or Core age 30 years when Commanded By Gen'l Nuelenbert [sic: Peter Muhlenberg] at the Battle of Hot Water Rec;d two wounds in his Legg which fractured Both the Tibea & Fibular & Not Withstanding all the Necessary Precaution that Could Be taken By Both Internal & External means it Hath Rendred Him a proper Invalid & Unfitt for Duty Given under my Hand as [illegible word]

In Augusta Virginia Martis De 21st 1786 Hugh Richey Chirurgeon Et M.D.

The within named James Hamilton a pensioner personally appeared & proved to the satisfaction of the court that he received his wounds in the service of the Commonwealth in Capt Patrick Buchanans Company of Militia from Augusta County in the action at Hotwater June 26th 1861. He is aged Thirty years & Resides in this County. he also produced the within certificate of his inability.

NOTES:

Alexander Hamilton in his pension application (S9556) stated that he and his brother, John Hamilton, nursed their brother, James Hamilton, after he was dangerously wounded at the Battle of Hot Water.

This appears to be the same James Hamilton as in pension application X315.
