I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." On this 16 day of June 1823 before me the subscriber a justice of the peace for the said County of Pittsylvania personally appeared Nathan Rowland, who on his oath declares that he is the same person who formerly belonged to the Company commanded by Captain Jo^s Morton in the Regiment commanded by Colonel Peter Perkins in the service of the United States. That his name was placed on the pension Roll of the State of Virginia but has never received a formal certificate & now wishes to obtain one.

It appearing to the court that Nathan Rowland from a wound he received at the Battle at Guilford Courthouse [March 15, 1781] is disabled from laboring to procure a livelihood and being a very poor man he is Recommended to the General Assembly as an object of Compassion.



I do hereby certify that the within named Nathan Roland's wound that he received at the Battle of Guilford was through his foot which has rendered him ever since unable to walk without a Crutch which was made appear to Pittsylvania court last September.

I Sergan [surgeon?] in the King of France Service and Continental Service in Pittsylvania County do hereby certify that Nathan Roland of the said County has been wounded in the Continental Service in one of his feet and the ball appears to me to have lodged in between the bones of his foot and therefore it appears to me that the said Roland is rendered incapable of getting his living. Given under my hand this 30 day of March 1786

I do, with the advice of the Counsel, hereby certify that Nathan Rowland of Pittsylvania about 30 years of age late a private in the 1st Regiment of Virginia Militia, appears to have been disabled in such a manner while in the Service of the United States as to entitle him to the sum of 6 pounds yearly; which allowance is accordingly made him, to commence from the 1st day of January 1786.

Do, with the advice of the Council, hereby certify that Mohan Powland of Billough about 30 years of age late a Private in the first Required of Virg.
